# Written Examination Dates 2019/20: Engineer Officers (Yachts, Sail Training and Small Vessels)

Notice to all Owners, Masters, Engineer Officers and Crews of Commercially Operated Yachts, Large Private Yachts and Sail Training Vessels and those concerned with **Maritime Training** 

This notice replaces MIN 573 (M) from 1 September 2019 This MIN expires 31 August 2020

#### **Please Note**

Where this document provides guidance on the law it should not be regarded as definitive. The way the law applies to any particular case may vary according to circumstances – for example, from vessel to vessel and you should consider seeking independent legal advice if you are unsure of your own legal position.

#### Summary

This notice sets out the written examination dates for Merchant Navy Certificates of Competency for the academic year commencing 1 September 2019.

#### 1. Introduction

- 1.1 In accordance with the Maritime and Coastguard Agency (MCA) Large Commercial Yacht Code (LY2)<sup>1</sup>, it has been agreed with industry that Certificates of Competency will be issued for service as Engineer on commercially operated yachts, large private yachts and sail training vessels. A Merchant Shipping Notice explains the background, and application requirements and procedures. Currently that is MSN 1859 (M).
- 1.2 Article IX of the Standards of Training, Certification and Watchkeeping (STCW) Convention allows an administration to adopt alternative arrangements of education and training for special types of ships and trades. The MCA has utilised this alternative arrangement to create a certificate structure for Small Vessel engineers (working in Yachts, Tugs, Fishing Vessels, Workboats, Standby, Seismic Survey, Oceanographic Research Vessels and Government Patrol Vessels). A Marine Information Notice (MIN) 524 (M+F) in parallel with MSN 1859 (M) explain the background, application requirements and procedures.

- 1.3 The syllabuses are available on the GOV.UK website.
- 1.4 The examinations are administered by the Scottish Qualifications Authority (SQA) on behalf of the MCA and are held at their examination centres in the United Kingdom, or by special arrangement at overseas centres. The written examination dates for the academic year commencing 1 September 2019 have been agreed following consultation with various representative organisations of the industry. Annex 1 and 2 set out the pattern of written examinations to be held between 1 September 2019 and 31 August 2020.
