JUDGMENT

Employment Tribunals Rules of Procedure 2013 – Rule 21

Mr G Condell - 1403635/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £2100.00.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £1938.48.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £3957.73.
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of £807.69.

Mr G McDonald - 1403636/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £2100.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £1938.48.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £4523.12.
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of £807.69.

Mr I Lennox-Gordon - 1403637/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £6645.20.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £5772.00.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £11784.50.
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of £2827.50.

Mrs M Lennox-Gordon - 1403638/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £**5448.34**.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £4773.00.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £10341.50.
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of £2338.12.

Mr S Jackson - 1403639/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £468.38.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £3552.00.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £2664.00.
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of £1575.00.

Mr P Przybylski – 1403640/2019

- 1. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £4037.28.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the sum of £**1480.00**.
- 3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of $\mathbf{f740.00}$
- 4. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the sum of $\pounds 1500.00$
