- Terminology and Grammatical changes.

In addition the following more significant changes have been implemented: RA 4943 – Revision to timelines on changes to appointed posts. RA 4545 – Addition of derogation for Mil CAMs operating civil derived Air Systems. RA 4951 – Quality Regulation separated into 3 distinct Regulations and now includes internal and external CAMO assurance stipulations. RA 4961 – Re-titled with addition of a new Regulation referring to Mil CAMO responsibilities for Air System Release. RA 4963 – Additional direction with respect to deferral of faults and locally manufactured parts. The raising of a new RA - RA 4965 – Local Manufacture Assurance. The raising of a new RA - RA 4966 – Mil CAMO Instructions. RA4972 – Revision of competence requirements of Mil AR surveyors. RA 4973 – Uplift of physical review requirements from GM to AMC as a result of the Sentry review. Despite the number of amendments there has been no change to the Regulatory intent, therefore the impact is assessed as negligible.
