## FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: POLICE FORCE PR BUDGETS.

We refer to your email dated 7 May 2019 to the Ministry of Defence Police which was acknowledged on the 8 May 2019.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- "What was the force's public relations and marketing budget for each of the following financial years...
- -2014/15?
- -2015/16?
- -2016/17?
- -2017/18?
- -2018/19?

Additionally, how many staff are currently employed in marketing, public relations and communications based roles?

Of those staff, how many earn above £50,000 per year? How many earn above £100,000 per year?"

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

- 1. The Ministry of Defence Police budget contained the following provision to support the force's external recruitment marketing programme during the periods requested:
  - 2014/15 £50K
  - 2015/16 £179K
  - 2016/17 £37K
  - 2017/18 £80K
  - 2018/19 £46K
- 2. The Ministry of Defence Police Corporate Communications department currently employs 5 full time and 1 part time member of staff, none of whom earn more than £50K per year.
