Appendix A: Terms of reference and conduct of the inquiry

Terms of reference

- 1. In exercise of its duty under section 33(1) of the Enterprise Act 2002 (the **Act**) the Competition and Markets Authority (**CMA**) believes that it is or may be the case that:
 - (a) arrangements are in progress or in contemplation which, if carried into effect, will result in the creation of a relevant merger situation, in that:
 - (i) enterprises carried on by LN-Gaiety Holdings Limited (LN-Gaiety) will cease to be distinct from enterprises carried on by MCD Productions Unlimited Company (MCD); and
 - (ii) the condition specified in section 23(2)(b) of the Act is satisfied; and
 - (b) the creation of that situation may be expected to result in a substantial lessening of competition within a market or markets in the United Kingdom for goods or services including the promotion of live music events with over 1,000 tickets capacity on the island of Ireland, including in Northern Ireland.
- 2. Therefore, in exercise of its duty under section 33(1) of the Act, the CMA hereby makes a reference to its chair for the constitution of a group under Schedule 4 to the Enterprise and Regulatory Reform Act 2013 in order that the group may investigate and report, within a period ending on 8 January 2020, on the following questions in accordance with section 36(1) of the Act:
 - *(a)* whether arrangements are in progress or in contemplation which, if carried into effect, will result in the creation of a relevant merger situation; and
 - *(b)* if so, whether the creation of that situation may be expected to result in a substantial lessening of competition within any market or markets in the United Kingdom for goods or services.

Conduct of the inquiry

- 1. We published the biographies of the members of the inquiry group conducting the inquiry on 25 July 2019 and we published the administrative timetable for the investigation on our webpage on 2 August 2019. This was updated on 15 October 2019.
- 2. On 9 August 2019, we published an issues statement on our webpage, setting out the areas on which the inquiry would focus.
- 3. On 21 August 2019, members of the inquiry group, accompanied by staff, visited the premises of Ticket Shop (N.I.) Ltd (**Ticketmaster**) and MCD in Dublin.
- 4. We invited a wide range of interested parties to comment on the Proposed Merger. We conducted telephone interviews with a number of customers and competitors of the Parties. Evidence was also obtained through further written requests. We also used evidence from the CMA's phase 1 investigation into the Proposed Merger.
- 5. We received written evidence from the Parties and a non-confidential version of their response to the phase 1 decision is on the case page. We also held a hearing with the Parties on 11 October 2019.
- 6. In the course of our investigation we sent the Parties a number of working papers.
- 7. On 7 November 2019, we published a notice of Provisional Findings and a summary of our Provisional Findings on the inquiry webpage. A non-confidential version of our Provisional Findings was published on the inquiry webpage on 8 November 2019. A non-confidential version of the Parties' response to our Provisional Findings has been published on the inquiry webpage.
