# Summary

#### **Closed Plenary Update**

1. The closed plenary had the primary aim of finalising the Annual Report. This was achieved and the report will be published in due course.

#### Work Programme 2019-20

- 9. The Subgroup has been compiling a history of the nuclear industry in the UK, with the aim of helping stakeholders to understand how nuclear waste came to be, so they can understand the present situation. SG1 will assess the



information it has compiled and decide on how best to present and utilise it going forward.

#### **Subgroup 2: Safety Case and Geology**

- 10. CoRWM members attended each of the venues of RWM's site evaluation meetings. The meetings were seen to be well organised and run.
- 11. SG2 have not met since the last plenary, but at their last meeting they agreed CoRWM's response to the site evaluation consultation. Since the last plenary this had been submitted to both the Welsh and English governments (in late March). The response would be published in the CoRWM Annual Report and on the CoRWM website.

## Agenda Item 5: Invited Speaker, John Corderoy of RWM

RWM's Programme Director, John Corderoy, provided a comprehensive Programme and Project Management (PPM) update to the committee. The briefing covered four key areas of development both within RWM and within the Geological Disposal Facility Programme. Firstly, the briefing covered the rationale for, and progress with, forming a new Programme Directorate within RWM. The Directorate has now largely finished its recruitment of c.20 new staff and is driving four programme management themes of: leadership, alignment, drive and centre of excellence (in PPM). The second area was in the development of refreshed planning data covering short, medium and long term GDF activities. The third update related to the status of major Business Case activity; particularly the early strategic case work that will underpin the full scope of activity covering future site characterisation, safety case and detailed design work. The fourth update covered work undertaken during 2018 to look at the long term development of RWM through all the major phases of activity associated with the GDF. This work will lead to a detailed development plan looking 5, 10, 15 years ahead, to ensure that RWM has the right structure and capabilities to deliver the GDF Programme in the coming decades.
