

Release of Information

Thank you for your correspondence of 27 September 2019 in which you requested the following information:

In accordance with the precedent of FOI 2019/07860 please supply me with results data for the PRMC course held at CTCRM, Lympstone, Exmouth, Devon, EX8 5AR between these dates:

24 September 2019 to 27 September 2019

The results for the following specific fields should be identified:

- 1. Withdrew prior to course commencing.
- 2. Failed 1.5 mile assessment.
- 3. Failed VO2 max test.
- 4. Failed to accumulate enough points.
- 5. Failed to achieve the minimum standard for pull ups.
- 6. Weak swimmer.
- 7. Candidate failed to display confidence at height.
- 8. Withdrawn by OC on Bottom Field.
- 9. Withdrawn by OC on Endurance Course.
- 10. Withdrawn at own request on Bottom Field.
- 11. Medical fail.
- 12. Swim fail.

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information (FOI) Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that information in scope of your request is held. The results for the Potential Royal Marines Course held at Commando Training Centre Royal Marines from 24 September to 27 September 2019 can be found in Annex A to this letter.

Please be advised that the numbers within the table cannot be broken down any further as disclosure could risk the identification of individuals which would put the Department in breach of our obligations under the Data Protection Act 2018 when handling personal data. Section 40(2) of the FOI Act applies to personal data relating to third parties and has therefore been applied with smaller numbers suppressed in line with Departmental policy on disclosure.
