## FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: POLICE OFFICER DOMESTIC ABUSE.

We refer to your email dated 11 July 2019 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- "1. Total reports of domestic abuse-related incidents and crimes perpetrated by police officers, PCSOs or staff, over three years up to April 2018
- 2. The role of the suspect / perpetrator (e.g. officer, PCSO, staff) linked to the above incidents and crimes
- 3. The gender of suspects / perpetrators linked to the above incidents and crimes
- 4. The gender of victims linked to the above incidents and crimes
- 5. The nature of the relationship between suspects / perpetrators and victim linked to the above incidents and crimes
- 6. The Crime Outcome Types / Codes linked to the above incidents / crimes
- 7. Any police misconduct process outcomes linked to the above incidents / crimes."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.
