# **Coastal Access – Whitehaven to Silecroft**

# Representations on VR7: Nethertown & Sellafield - and Natural England's comments

# 1. Introduction

This document details representations we have received on the stated coastal access report. These fall into a single category:

• Representations received from persons or bodies that must be sent in full to the Secretary of State ('full' representations, reproduced below).

In relation to the stated coastal access report, we did not receive any representations from those persons or bodies whose representations we are not required to send in full to the Secretary of State ('other' representations).

The document also sets out any comments that Natural England chooses to make in response to these representations.

## 2. Background

Natural England's report setting out its proposals to vary the approved route at two locations between Whitehaven and Silecroft was submitted to the Secretary of State on 26<sup>th</sup> June 2019. This began an eight-week period during which representations and objections about the report could be made.

In relation to the variation report for Nethertown and Sellafield, Natural England received 4 representations, all of which were made by organisations or individuals whose representations must be sent in full to the Secretary of State, in accordance with paragraph 8(1)(a) of Schedule 1A to the National Parks and Access to the Countryside Act 1949. These 'full' representations are reproduced in Section 3 of this document together with Natural England's comments where relevant.

Before making a determination in respect of a coastal access report, the Secretary of State must consider all 'full' representations, together with Natural England's comments on each.

We supported Natural England's original proposed route, which was based on undertakings by Network Rail that would have facilitated the installation of the path. We are disappointed that Network Rail has chosen not to support the coast path in the way it had initially indicated and that their decision has added to the cost of installing this section. We are not aware of proposals that would bring this land into operational railway use in the foreseeable future. However, we support Natural England's revised route.
