## Freedom of Information Request Collision and Casualty numbers in East of England

Thank you for your email of 20 January 2020 requesting information about collision and casualty numbers in the East of England. I have dealt with your request under the terms of the Freedom of Information Act 2000.

I confirm that we do hold the requested information. However, under <u>Section 21</u> of the Freedom of Information Act, we are not required to provide information which is already reasonably to you. The information you requested is available via the gov.uk website at <u>https://data.gov.uk/dataset/cb7ae6f0-4be6-4935-9277-47e5ce24a11f/road-safety-data</u> where there are tables for the national stats19 dataset covering at least the period 2010 to 2018.

We do hold some data about collisions and casualty numbers in the East of England for 2019. However, it is not our policy to provide data that is not validated and may not therefore be accurate. The information will be published by the Department for Transport later this year once they have completed its validation.

I am therefore withholding 2019 data in reliance of <u>Section 22</u> of the Freedom of Information Act, information intended for future publication. This is a qualified exemption and therefore subject to a public interest test. We have applied the test and found that withholding the information outweighs publication at this time. A copy of the public interest test is attached to this reply.

If you are unhappy with the way we have handled your request you may ask for an internal review.
