

NOTICE OF ORDER

Highways Act 1980 – Section 118

Herefordshire Council
Footpath MR45A Marden Public Path Extinguishment Order 2019

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **Wednesday 10 June 2020**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to extinguish that length of Footpath MR45A in the Parish of Marden which commences at OS Grid Reference SO 5204, 4748 (point A on the order plan) at County Road C1120 and travels in a generally west-north-westerly direction for approximately 347 metres to OS Grid Reference SO 5178, 4759 (point B on the order plan). Total length of path to be extinguished is 347 metres.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 24 June 2020]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 5 August 2020]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every

person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 16 September 2020]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

We cannot accept any libellous, racist or abusive comments. Any documents containing such comments will be returned.

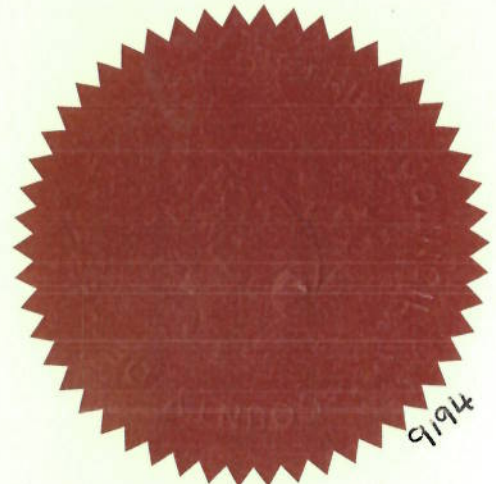
This order is made by the County of Herefordshire District Council (known as "Herefordshire Council") under section 118 of the Highways Act 1980 because it appears to Herefordshire Council that the line of the footpath described in the Schedule to this Order is not needed for public use.

BY THIS ORDER:

1. The public right of way over the land situated at Orchard Green in the parish of Marden and shown by a bold continuous line on the plan forming part of this order ("the order plan") and described in the Schedule to this order shall be extinguished after 28 days from the date of confirmation of this order.
2. Where immediately before the date on which the said footpath is extinguished there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of their undertakings, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

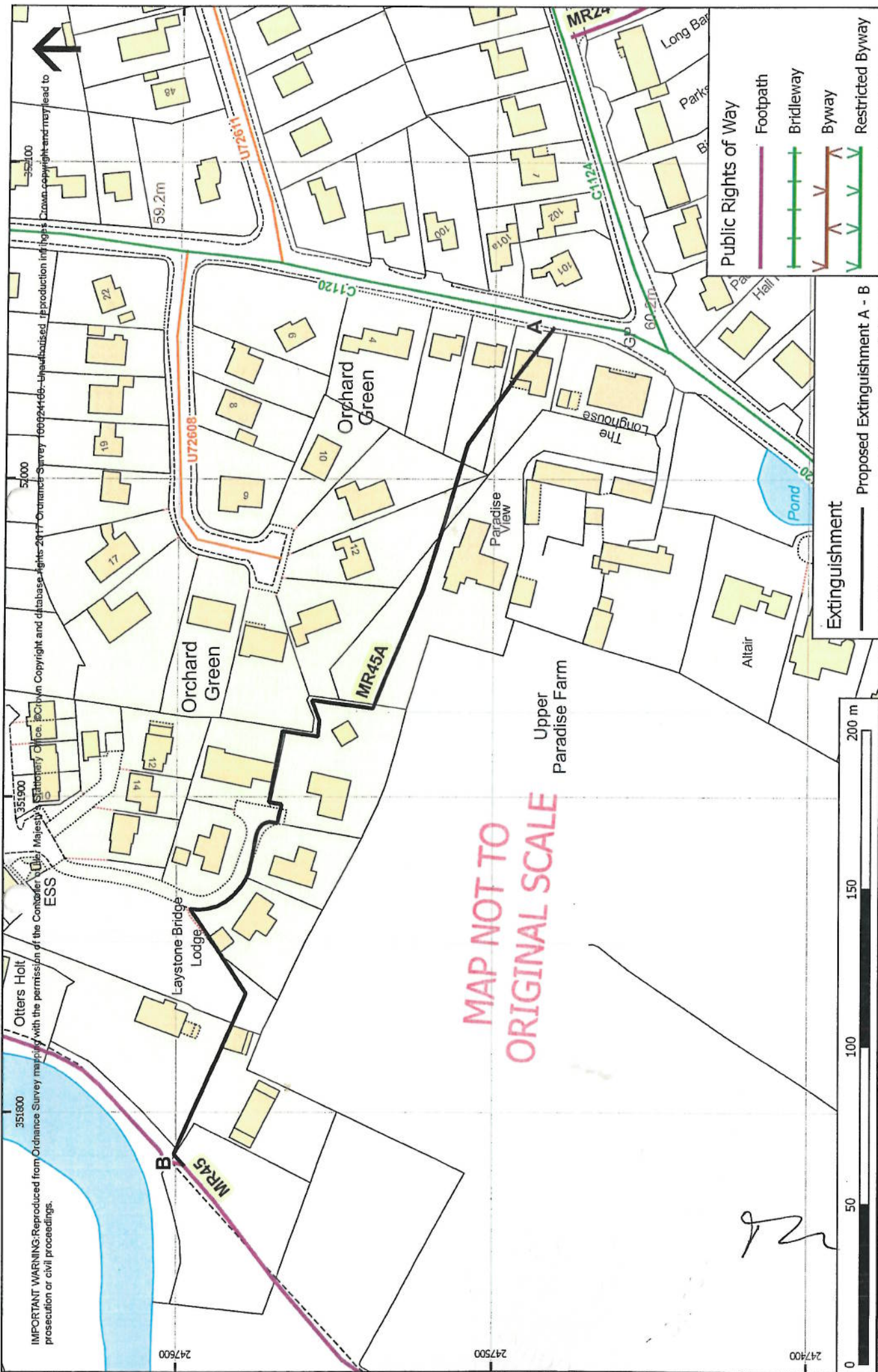

SCHEDULE

The route of footpath MR45A to be extinguished commences at OS Grid Reference SO 5204, 4748 (point A on the order plan) at County Road C1120 and travels in a generally west-north-westerly direction for approximately 347 metres to OS Grid Reference SO 5178, 4759 (point B on the order plan).

Total length of path to be extinguished is 347 metres.
