Thank you for your letter of 30 May in connection with a leaflet you were told had been issued by the MOD, citing indicators of extreme right wing views, in which you requested the following:

- 1. Confirmation that such a leaflet has been issued;
- 2. I require 5 copies of the original leaflet;
- 3. I want to know why such a leaflet was issued and on whose orders;
- 4. Was this leaflet produced by Army officers alone or in conjunction with civilians?

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that the information in scope of your request is held.

Part 1) We can confirm that the indicator card you refer to as a leaflet has been issued to a select number of forums where the Prevent /Channel process has been briefed.

Part 2) Please find enclosed one copy of the indicator card which you can use to produce more copies if you so wish.

Part 3) Work on the indicator card started following the arrest of four soldiers accused of alignment with the proscribed terrorist organisation National Action in 2017. It was a result of an initiative supporting the Prevent/Channel referral process.

Part 4) It was produced by both military and civilian personnel.

Under Section 16 (Advice & Assistance) you may find it helpful to know that Channel is part of the Prevent strategy. The process is a multi-agency approach developed by the Home Office to identify and provide support to individuals who are at risk of being drawn into terrorism. Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed. ## **EXTREME RIGHT WING (XRW) GROUPS IDEOLOGY**

Extreme Right Wing (XRW) Groups are **openly racist**, **anti-Semitic**, **anti-Islam and homophobic** in views. Generally, they take their inspiration from Adolf Hitler and the Nazi regime.

Members/followers encourage the **oppression of, and violence against, groups of people** based on their supposed inferiority. XRW followers perceive such groups as a threat to national social institutions or traditions. XRW groups reject current views on democracy and are hostile to British governmental structures. They seek to **divide society by endorsing violence** against ethnic minorities and perceived 'race fraitors'.

XRW groups and individuals **glorify those who have previously used extreme violence** for right wing political or ideological ends.

They look to spread their ideology through Social Media, stickers, leaflets, graffiti, street demonstrations and stunts aimed at intimidating local communities.

Under the Terrorism Act 2000, the Home Secretary may proscribe an organisation if they believe the organisation: commits, prepares for, participates in, promotes, encourages, glorifies acts of Terrorism.

National Action (NA), a racist neo-Nazi group, was proscribed December 2016. In September 2017, the Government directed that Scottish Dawn and National Socialist Anti-Capitalist Action (NS131) should be regarded as alternative names for National Action, so are also proscribed.

## Look out for individuals who...

Describe themselves as 'Patriots'	Look at opponents as 'Traitors'	Refer to individuals ready to challenge their XRW views as being 'indoctrinated'	Refer to Political Correctness as some left wing or communist plot	Use blatantly untruthful or incorrect references to immigrants, Judaism or Islam
Add 'istan' to British place names	Use the term 'Islamofacism'	Make generalisations about Muslims and Jews	Make inaccurate generalisations about 'the Left' or Government	Talk of an impending racial conflict or 'Race War'
Describe multicultural towns as 'lost'	Discuss the creation of 'white only' communities	Claim that immigration is the root of injustices against vulnerable people (e.g. old age pensioners, veterans)	Threaten violence when losing an argument, although claiming that XRW groups protest peacefully	Claim that it is acceptable to abuse Jews or Muslims as Judaism or Islam are not 'races'
Have tattoos with overt and covert XRW iconography	Become increasingly angry at perceived injustices or threats to so called 'National Identity'	Involve colleagues in closed social media groups	Actively seek out impressionable individuals to indoctrinate or recruit	Have extreme XRW group stickers or badges on clothing and personal items
