## **FREEDOM OF INFORMATION ACT 2000 - REQUEST REF: FOI 1155-19**

Thank you for your email of 22nd November 2019 asking for information under the Freedom of Information Act (FOIA) 2000. You asked:

*I would like to request the following information under the Freedom of Information Act:*

*I have been informed that you awarded on 31 October 2019 your CCTV Hardware tender to Sovereign International Ltd, and that two companies in total submitted bids for evaluation.*

*Please could you supply the name and registration number (Companies House number) for the unsuccessful company, excluding any commercial details of the tender outcome.*

*If you could supply this information electronically it would be appreciated. I understand you will be able to reply to this FOI request within 20 days, and please do not hesitate to contact me if you require further clarification.*

I am writing to confirm that we have now completed the search for the information which you requested.

I can confirm that FCO Services does hold information relevant to your request. The name of the company is EDS Limited and the Companies House registration number is 04186238.
