THE ENVIRONMENTAL PERMITTING (ENGLAND AND WALES) REGULATIONS 2016

The Environmental Permitting (England and Wales) (Exercise of Functions) (ITW Ltd) Direction 2019

The Secretary of State, in exercise of the power conferred by regulation 33(1)(b) of the Environmental Permitting (England and Wales) Regulations 2016(a), gives the following direction.

Citation and commencement

1. This direction may be cited as the Environmental Permitting (England and Wales) (Exercise of Functions) (ITW Ltd) Direction 2019 and comes into force on the day after it is made.

Interpretation

2. In this direction—

"the 2016 Regulations" means the Environmental Permitting (England and Wales) Regulations 2016 as amended.

"operator" means ITW Imagedata, a division of ITW Ltd;

"premises" means the premises listed in Schedule 1;

"relevant activities" means the activities listed in Schedule 2 carried out at the premises;

Exercise of functions

3. From the date this direction comes into force until 14 November 2024 or earlier revocation, the relevant activities exercisable under the 2016 Regulations by the Environment Agency in respect of the operator at the premises are exercisable by Babergh District Council.

Special Waste Storage	Storage of solvent and liquid waste prior to off- site disposal	From formation of waste to dispatch for off-site disposal
