The bid form explained

This free school bid form is for local authorities seeking to establish new special or alternative provision (AP) free schools.

Local authorities (either as a lead or sole bidder) can submit a bid for one special and one AP school in total in their area. Given the limited number of new schools we will create in this wave, it is highly unlikely that we will approve more than one school in any one local authority area. In the most exceptional of circumstances where you plan to make the case for two new schools in your area, you will need to complete a separate bid form for each school, although you should crossreference where appropriate.

The overview section on the second tab asks for information about the number of bids you are submitting (i.e. one or two), the priority of each bid (if you are submitting two), what (if any) other bids you are supporting, and your expected future need for new special and AP schools (and when they are needed). If you are submitting two bids, you only need to complete the overview page on one form.

If your bid is successful, the opportunity will be advertised nationally, and if a strong proposal comes forward, the new school will be delivered and funded as part of the department's central free schools programme.

Box C1 - the current context in your area

In Newham, most children and young people with special educational needs and disability (SEND) have their needs met in mainstream provision and Newham has a strong legacy and commitment towards inclusion. Around 90% of high needs funded pupils with autism attend mainstream schools, including resourced provision. The high levels of need of a number of children and young people require even more support and expertise than can be offered in mainstream and resourced provision. The existing provision at JFK School is already at capacity and more pupils are having to attend out of borough (OOB) provision due to the lack of suitable places.

The increases in the school aged population are well documented rising by around 21% from 2010 to 2018. Over the same period, the increase in high needs funded pupils has risen by 88% and analysis shows that the highest rise is autistic spectrum disorder (ASD) funded pupils increases by 278%. Out of Borough (OOB) ASD places have increased by 54 pupils, **and analysis and analysis**. The next highest increase was SEMH that increased by 11 pupils.

The current high number of primary ASD pupils will transfer into the secondary sector in a similar way as also seen in the mainstream sector. Without any further increases in primary numbers and a year 6 to year 7 transfer rate of 100%, this would see the numbers on roll in schools increase by around 53% over the next 10 years.

The proportions of ASD funded pupils shows a reasonably consistent split of: 90% of pupils in mainstream schools including resourced provision; and 10% of pupils attending out of borough settings and JFK special school.

The trend for funded ASD pupils suggests an increase of around 830 pupils to 2025, with pupils attending out of borough settings and borough special school places rising by around 96 to 205. Maintaining OOB placements at a level of 60 would leave 145 needing special school places. A breakdown of pupils by phase shows the greatest number would be in the secondary phase. The current provision at JFK school of 45 places for autism leaves a need for an additional 100 places. A float of 5 places allows for a small working margin and potential OOB applications.

The forecast growth in need means that a range of additional specialist provision will be needed, of which a special school would be part, alongside additional resource provision within mainstream schools.

The local authority undertook a wide consultation in 2017 identifying key areas for development across services, phases of education and broad areas of special educational needs and disabilities. The findings formed the Best for All atrategy that is part of a wider Council strategy to improve education, health and well-being outcomes for children and young people. This strategy provides a blueprint for our providers and all those working in the local authority and health services with children, young people and their families. Priorities will be identified and change implemented, through planning and the commissioning of inclusive education, health and social care services for children and young people with SEND. To ensure that children, young people and their families receive a high qualityand inclusive service, we will put in place robust governance and quality assurance measures. This will include challenging education providers and universal services to be more inclusive of children and young people with special educational needs or who are disabled. It will involve working in partnership to effect change through the implementation of plans that will: affirm our commitment to parental choice, the inclusive education of children and young people with special educational needs and disabilities and the removal of barriers to learning and participation in mainstream schools; • provide more effective systems for the collection and collation of data upon which to plan and commission services and track the progress, attainment and life outcomes of children and young people with special educational needs and disabilities • establish needs driven, evidence based, outcome focused models for the commissioning of education, social care and health services; clarify thresholds for intervention and support and delivering greater integration and coordination of services to meet the needs of children and young people with special educational needs and disabilities and their families • ensure a clear conceptual model of universal, targeted and specialist support and commission the specialist education provision that is required to meet the needs of children and young people with special educational needs and disabilities across the 0-25 age range including early years and post 16 provision; deliver improved assessment and identification of need, develop a shared approach and model of person-centred planning and ensure complex needs are met and assessed effectively; • ensure sufficiency of specialist provision for those children and young people with the most complex needs; improve access to provision including pathways and transition arrangements: make explicit admissions criteria, referral routes and reintegration pathways: • deliver a funding model for the allocation of high needs funding for special educational needs and disabilities that is transparent, equitable, based on clear criteria and supports children and young people's person centred learning pathways, and ensure robust governance and quality assurance measures. One of the fastest growing areas of need identified within Best for All is for pupils with ASD.

In Newham's mainstream and resourced provision settings there is currently a practise of supporting and funding children and young people without an education and health care plan (EHCP), whereas in other LAs they would have a Plan and been through the statutory assessment process. For 2017/18 this was around 1,200 pupils across the borough. The intention is to ensure that all children and young people go through the statutory assessment process and where appropriate have an EHC Plan.

The high levels of inclusion that Newham is well known for both nationally and internationally will be maintained. The increase in special educational needs and disabilities pupils with be managed around keeping inclusion levels high. This is supported by the 34 additional resource provision places made for September 2018 rising to an additional 105 places in the next two to three years, 79 of those places are specifically for ASD children and young people.

The forecast increases mean that even with an additional 105 places in a new special school the number of pupils in mainstream schools and in resource provision will still increase and the current proportionality of Newham pupils in Newham schools will remain. Reducing the number of pupils attending schools in other local authorities and independent settings is an essential part for future special educational needs and disabilities in Newham allowing pupils to attend local schools. This would at the same time reduce in real terms the levels of expenditure from the high needs block of the dedicated schools grant for fees and reduce the level of expenditure for out of borough transport.

A new school would be a centre of excellence supporting the needs of all schools in Newham. The opportunity to work in partnership with mainstream, resourced provision and special schools alike would make this new school a beacon for good practice and expertise across Newham. A school could play a role in driving up standards for SEND across Newham, with a greater concentration of specialist staff than is possible in other provision.

This inclusive approach to a special school could include pupils from mainstream schools attending for short periods of time for specialist support and then returning to mainstream and resourced provision.

The new school is necessary to meet the growing demand for autistic spectrum disorder (ASD) specialist places and already Newham is seeing an increase in numbers and has started to address this with addition resource provision places through expansions at one primary school and new proviaion at two primary schools and a sixth form college totalling 79 additional ASD places when fully occupied. There has been difficulty in finding suitable places especially for year 6 to year 7 transfers and is making temporary arrangements for additional places for John F Kennedy School (JFK) on a separate site. The additional need is on-going and further special school places are required and until significant provision is provided through the new free special school there will need to be further temporary arrangement to cater for an additional 25 places to 2022/23. In addition, we can anticipate increases in out of borough, resource provision and mainstream places.

The current special school JFK is on two sites, One site catering for profound and multiple learning difficulties and complex needs pupils and the other school catering for up to 45 ASD pupils. The ASD school is at capacity and a restrictive site and there appears to be no easy solution to tripling the size of the school to provide an additional 105 places. The site is restricted further by the presence of major statutory services to the west of the site preventing any building in that specific area and would make a complete rebuild unachievable and far costlier than building a new school.

Whilst a new free special school would be the second ASD school in the borough the schools are expected to complement and support each other inl taking the most complex needs. The new school in its role as a centre of excellence for ASD will provide support for all schools, including resourced provision and special schools.

We have undertaken a call for views with parents, schools and other stakeholders during September. Further details are in included with this form. This includes over 30 parents attending two meetings, two headteacher meetings, and 59 written responses. The majority of parents and all schools which responded are in support of a special school bid. The main reasons given in favour are better meeting the needs of pupils with very complex needs, concerns that there is currently insufficient specialist provision and giving parents more choice. However a minority of respondents are opposed, including a number from the Alliance for Inclusive Education, citing concerns that special schools do not support inclusion.
