The bid form explained

This free school bid form is for local authorities seeking to establish new special or alternative provision (AP) free schools.

Local authorities (either as a lead or sole bidder) can submit a bid for one special and one AP school in total in their area. Given the limited number of new schools we will create in this wave, it is highly unlikely that we will approve more than one school in any one local authority area. In the most exceptional of circumstances where you plan to make the case for two new schools in your area, you will need to complete a separate bid form for each school, although you should crossreference where appropriate.

The overview section on the second tab asks for information about the number of bids you are submitting (i.e. one or two), the priority of each bid (if you are submitting two), what (if any) other bids you are supporting, and your expected future need for new special and AP schools (and when they are needed). If you are submitting two bids, you only need to complete the overview page on one form.

If your bid is successful, the opportunity will be advertised nationally, and if a strong proposal comes forward, the new school will be delivered and funded as part of the department's central free schools programme.

Warwickshire are submitting a Solo bid. Consultation ahs occured with our counterparts in Solihull, Coventry and Stafforshire and they do not feel that the area that we need this provision would support their students needs becsause: A) Solihull already has a PRU and an AP free school. b) Coventry has a PRU that is currently meeting the needs of their students. C) Staffordshire also has a PRU and the location of the Free school in the North would not be in a reasonable distance to serve the needs of Staffordshire students. Worcester also has PRU and AP free school provision that is not within a reasonable distance for WCC students to travel to. We did not engage with Leicester or Oxfordshire as there are very few students who attend provision from these area in WCC and vice versa.

WCC will commission the top up for all places at both AP Free schools in the first two years of opening at the time in year 1 and in year 2. In the third year WCC will fund 17 FTE places top up at the secondary heads across WCC. A working group from the steering group has helped to shape what the provision would look like, what areas it would need to serve and we have created a financial template as used for setting up an AP free school to generate the financial model and subsequent top up rate of the trace of the the AP free schools are instrumental in delivering better provison for Warwickhisre vulnerable students that is value for money. The schools have provided a letter of support stating how places they will want to commission from their schools. WCC has consulted with all the schools on how the DSG funding would be utilised including releasing the the WCC commission ing 17 FTE places. We have met with cabinet members and the overview and scrutiny group committee and they are in full support of the need of the AP Free school.

We are looking for bids in areas where a new school will most support local authorities to manage current and/or anticipated pressures on special school places or on the overall high needs budget, so that the needs of children can be better met. We will not be inclined to approve bids that have the side effect of decreasing the inclusion in mainstream schools of children with SEN, or who are at risk of permanent of fixed term exclusions, or of creating excess spare capacity in existing special or AP school. Bids will score more highly if they can demonstrate that a new school will be filled by students who would otherwise be going to more expensive or poor performing provision.

Box C1 - the current context in your area

Warwickshire County Council have no Pupil Referral Units (PRU) for either primary or secondary school aged students. When young people are permanently excluded from secondary schools it is taking on average 12 months- 18 months to get them back into schools from the AP world.

The alternative provision commissioned is from a) one college, which is RI. This provision is also challenging if the college fails the placement because this also stops them from being able to attend that college in P16. b) From 24 private alternative providers in the whole of the county: The quality of these private alternative providers ranges from RI to Inadequate. There is only one of these AP private providers that is a registered independent alternative provider and is RI. The remainder of the AP provision is part time and students have to travel to more than one provider to access their full entitlement. However there is a perverse incentive for these private providers to keep the students in AP and therefore they do not prepare students for returning to mainstream or supporting schools with preventative programmes. The average cost for the alternative provision is approximately per FTE placement. Without the new school we would have to continue utilising our current provision, work with the providers to become registered. The situation is fragile with private providers and this is just not sustainable.

The latest 2016-based subnational population projections suggest Warwickshire's 0-18 population will increase by nearly 5,000 young people or 4% between the 2016 base year and 2026. The largest expected growth will be seen in the Secondary school age ranges (ages 12-18), which will see an increase of 13% by 2026 (up from just over 43,000 to 48,695 children). Student growth figures for North Warwickshire, Nuneaton and Bedworth show an average growth of 11% by the year 2024/25. The population of SEN students has grown by 42% over the past 8 years across WCC.

All alternative provision is commissioned by the schools through 4 area behaviour partnership that have had the DSG funding line for the whole of
WCC, allocated to the North area) devolved to them to commission alternative provision and manage permanent exclusions. Currently we have 96
students from mainstream schools receiving home tuition as a result of illness and a further 63 on the SENDAR list. In 18/19 - 453 EHE students across WCC
291 = 64% are KS3/4.

Permanent exclusions over the past 5 years have been consistently above our statistical neighbours and rising e.g. 2014/15 = 54, (Statistical Neighbour 43), 2015/16 =65, (Statistical Neighbour 51), 2016/17 = 67, (Statistical Neighbour 64) and 2017/18= 77 (Statistical neighbour data not available). 37 of these exclusion came from the schools in the North of the county and Nuneaton and Bedworth. In addition to this there are 72 other students from this area that were at risk of permanent exclusion who are also attending alternative provision. In total that means that we currently have from the North/Nuneaton and Bedworth area 109 secondary aged students who require AP. Without the AP Free School creating a revolving door model that support students back into mainstream, by 2024/5 we would require AP placements for this area alone to be approx 121 students.

WCC AP strategy aims are to ensure:

• The right children are placed in AP:

• Safeguarding: some young people at current alternative provision in WCC are not attending and providers are not effective at improving this.

• Children have good experiences of, and receive high quality education in, AP

• Children achieve meaningful outcomes after leaving AP:

• AP is recognised as an integral part of the education system:

• the system is designed to achieve high quality outcomes for children and value for money for the tax payer.

• We want to remove the barriers for mainstream schools to keep these students on roll, reducing exclusion and preventing any form of off rolling that may be influence by the narrowing curriculum and achievement agenda.

WCC AP strategy for change as part of a wider strategy(see WCC WE strategy leaflet)

In 2017/18, following a review and consultation with schools, WCC has re centralised the secondary DSG funding for AP.
WCC has launched a new education strategy (Warwickshire Education (WE) Strategy). This strategy has four priority areas WE1, WE 2, WE3, WE4. Each "WE" refers to a given priority area.

• WE2 Priority is: "Our challenge is to promote a broad, empowering and creative curriculum focusing on times of transition and prioritising vulnerable groups." WE2 is further split into 5 strands with WE2 (a) focusing on the wellbeing and educational outcomes of learner's currently missing education and those who may require alternative provision for a variety of reasons.

Delivering WCC AP strategy for change as part of a wider strategy (Please see attached delivery plan and PowerPoint):

• In delivering WE2(a) WCC has merged the teams, that deal with any child that is at risk of missing education for any reason e.g. ABP's, Elective Home Education team, Fair Access Panel team, Exclusions team, Children missing in Education team, Looked after Children safeguarding, and Access to Education team (EWO).

• WCC has relaunched a new AP framework exercise calling all AP providers who want to operate within WCC to express an interest and following a quality assurance and evaluation of tender's we will create an AP directory.

• Only those providers on the framework will be able to be commissioned.

• All AP will eventually only be commissioned through the AP Free school broadening the curriculum offer that the Free school can offer, as well as creating a gateway that raises the bar in relation to the standards of other AP operating in WCC. This also allows for students to be re-integrated back into mainstream via the Free school revolving door-short stay programme. This will not affect the current provider who offer good value for money provision within WCC currently.

• All AP providers on the framework will attend an AP alliance group which is designed to support providers to improve their quality and move towards becoming registered providers and also buddy them with their mainstream colleagues.

• The Area Behaviour Partnerships will become the forum through which all students will be referred into and out of AP and therefore become the admissions forum for referrals into the AP Free school.

 This will also be the forum that monitors the managed moves processes and be able to identify future need. This brings all the key stakeholders together taking collective responsibility for the provision of AP students. We will be developing the

intervention ladder matris (in line with SEND and inclusion strategy) to inform schools of interventions they can employ to support students within mainstream informing more accurate assessemnt of students need for AP or EHCP's. This should make sure we have the right students in AP and not put the assessment process for EHCP under unneccessary pressure allowing timely EHCP to be issued in line with the code of practice.

• WCC has developed a centralised "in year" referral system for any child that may need to be referred into or out of any school for any reason e.g. managed move, access to alternative provision, Pex, Fair Access Protocol students, school refuser etc).

WCC are creating a coding system that will be attached to those students who may fall within this category. Students that will have this code assigned to them will fit into an agreed set of criteria and we all agree would be "Outliers" on any schools progress 8 data. This will allow us to take the pressure of schools not re-admitting these students after a period in AP or keeping all students on roll even if they have been referred to AP instead of being permanently excluded.
We have already engaged with HMI on this coding project and we are now in discussion with the national HMI lead for AP and behaviour to look at how we will be able to provide a set of shadow data for schools and Ofsted that shows what progress really looks like for this category of students e.g. Progress 5.

We have created a national partnership with Warwick University, Achievement for All, the charter school of teaching and Ethical Leadership to monitor our strategy for ethical inclusion so we can share it wider beyond WCC following evaluation
This process involves: The referring body (including schools) completing a Learner Information Form (LIF) sending it one point of contact within WE2 (a) team.

• At this point of contact this student's unique reference number and details are entered onto a new database that is synchronised with social care, youth offending and school data and finance databases.

• This brings all the information on this student into one learner passport that allows us to triangulate all the relevant agencies to work collaboratively and see what the journey for this student has been to date in order to inform their next steps.

• It will also allow us to track these students beyond this point of referral and link this passport to their final outcomes and destinations were to and to the financial cost in delivering those outcomes allowing us to be more strategic to make and inform value for money decisions.

The school is needed because we don't have appropriate quality AP provision in the North/Nuneaton and Bedworth area that is seen as an integral part of the continuum of education.

The profile of the students, who will be referred, will be in-line with Warwickshire local authority fair access protocol i.e.

• Students not on any school roll who fall into the category of "Hard to Place" as outlined in the fair access protocol.

• Students on roll at a school who are at risk of immediate permanent exclusion.

• Students on roll at a school, where all other interventions including managed moves have failed and it is now deemed appropriate that alternative provision is considered.

• Some of these students may be students with additional needs but have not had a statement issued eg. ASD, SEMH.

The purpose of the placement will meet the needs of 11-16 year old students that :

a) Provide short stay programmes (6-12 weeks) for students who may have been permanently excluded and are identified a new school place and following some re-orientation programmes are supported from the Free school to re-integrate back into mainstream schools.

b) We also recognise that there may be some students for whom the mainstream curriculum model is not engaging them and a part time programme of vocational options (1 or 2 days a week, this is where some other AP provision can be commissioned to widen the curriculum offer). This will enable students to remain engaged in their mainstream education and prevent permanent exclusions.
c) Likewise we also recognise that there may be other students, who are able to access GCSE's, however a smaller setting is required to engage them these students would access full time provision at the Free school.

Based on IDACI, 28% of children attending schools in Nuneaton and Bedworth district live in the top 30% most deprived areas nationally. This is closely followed by those attending schools in North Warwickshire where 21% live in the top 30% most deprived areas. Locally held data identifies Nuneaton and Bedworth as an exclusions hot spot. By having the AP free school (North) based in Nuneaton this will make this provision easily accessible for those students who require it.

The high needs funding for behaviour is **accessed**. We have consulted with all stakeholders on the use of the High Needs Budget to support base funding **accessed** on going. WCC will support the full funding of placement in this AP free school for the first two year of opening as we get the SEND and inclusion strategy fully embedded. Schools and WCC will jointly commission placement from year 3 onwards in line with evidence of commissioners.

There are 15 secondary schools in the North of WCC. There is one secondary special school that is a grade 2 Ofsted rating. 10 of

All referrals into the Free school will happen via the Area Behaviour Partnership behaviour leads meetings that take place every 5/6 weeks. All referrals will be scrutinised to ensure appropriateness of referrals into the AP free school. If it is agreed that a placement at the Free school is appropriate an exit strategy will be identified at this point including identifying a new school placement. This model ensures that a partnership approach which has collective accountability at the centre of it as well as appropriate professional challenge to ensure all partners are being ethically inclusive. This will also allow WCC to monitor the flow of students into and out of the free school ensuring were appropriate a timely return to a mainstream school.

The evidence from here will provide WCC with data on evaluating each schools behaviour around ethical inclusion, informing the Kitemark award, the allocation of the code and shadow data to support schools with their outliers debate with Ofsted. We are engaging with HMI on this strategy and explaining that this Kitemark and code is a temperature test on how WCC is ensuring all its schools are ethically inclusive. This is already holding a lot of weight with the schools.

We want students to be accessing GCSE qualifications so they do not fall behind their mainstream counterparts whilst at the Free school and that they leave with the same academic currency as they would if they were attending any mainstream school. We would expect 50% of the cohort to be on short stay programmes and be re-integrated back into mainstream education either full time or a hybrid of mainstream and part time at the free school.

We would expect that at any one time there would be approximately 10 students being supported back into mainstream schools. The Free school colleagues will be able to support mainstream schools to meet the needs of the students in the mainstream setting and if necessary provide coaching and mentoring to upskill staff.

Ideally if the AP free school is part of a teaching school we would also see the Free school providing work experience for mainstream colleagues to learn within the AP setting e.g. have WOW- "watch other work" open day for mainstream colleagues in the mainstream and vice versa.

We see the AP free school as comparable to an intensive care unit in a hospital but like in the hospital analogy it is not separate from the general hospital. Likewise the AP free school provides intensive support when needed and returned to the mainstream with the guidance on how to support within the main. The AP free school will also provide the support to any full time student when they progress onto P16 colleges, sixth form or employment and training. The exit strategy and support plan for these students would require ongoing monitoring and visits to those free school students who progress onto p16 for the first year following leaving GCSE to ensure they do not become NEET.
