	b. The Committee noted that firstly there was a small reduction (£50k) in overall annual costs from the existing allowances. 

5. Commando Badge	a. It was noted that some elements of 3 Cdo Bde are wearing unauthorised Commando badges. The Chairman was conscious that unofficial badges worn over a period of time were often considered to be authorised by default. He directed that HQ DRA and other wearers were to be informed that this badge is not authorised. Sec ADC was to seek the agreement of the views of relevant A&SDs on the badge. Should a requirement for a badge be agreed, this would be considered by the Committee. Should a badge be agreed, a design would be tabled to A&SDs.	Sec ADC

8. Outfit Allowance	 a. The Sec briefed the Committee on the proposed way forward. The Allowance had not been reviewed or changed for some years and bore no relationship to the current cost of items to be purchased as listed in JSP 886. Indeed the list of items to be purchased in this JSP was to be reviewed in conjunction with HQ LAND. Once this review had been completed, the current cost of commissioning could be compared with the Allowance. It was understood that the introduction of FAD No 2 Dress was predicated on a reduction of £700 from all officers Outfit Allowance. b. The linkage between the Allowance and the Uniform Maintenance Tax Rebate received by officers annually needed to be established and confirmed. It was likely that the Treasury would wish to review the Tax Rebate if the Allowance was changed. The Tax Rebate amounts to some £240 a year. Those officers who have had to spend considerable sums of money to change their mess dress and other uniforms as a result of FIS would receive over £1000 in tax rebates over the next 5 years as compensation. Any reduction in compensation. In addition, any recommendation to increase the Allowance would be very unlikely to succeed unless some assistance to purchase mess dress was also given to newly promoted members to the WO and Sgts Mess. c. The Committee noted that this whole area is particularly sensitive and looked forward to seeing figures at the next meeting. PS10 and PS12 were to present DAG with a reasoned estimate of the real costs of uniforms required, revised scalings and figures post-FAD No 2 dress introduction. d. After discussion, it was agreed that scales would be moved to a chapter within the new Army Dress Regulations (ADRs). 



TERMS OF REFERENCE

1. The Committee considers any proposal to introduce or alter the State, full, mess, parade, walking out and barrack dress and ceremonial accoutrements of the Army; and the badges, insignia and embellishments to be worn with all forms of dress, and submits recommendations to ECAB when necessary. The Committee implements overall policy on Army Dress as directed by CGS, and examines and makes decisions on any detailed aspect, change or modification to all non-operational Army dress on behalf of AG and CGS.

2. The Committee takes into account all cost implications of proposals considered by it and identifies TLB funding.

3. Detailed tasks include:

a. Maintain close liaison with DC IPT on the development and supply of Army Dress – both in-scale and new to service (NTS).

- b. ADC representation on:
 - i. The Defence Clothing Customer Advisory Group (DC CAG).
 - ii. Operational Clothing Capability Working Group (OCCWC) as a Customer 2.
 - iii. The Public Duties Quarterly Review.

c. Sponsor uniform clothing pamphlets in appropriate single and joint service publications and Army Dress Regulations.

d. Sec ADC representation on the Future Army Dress Working Group (FAD WG).
