<b>Item 6. Gurkha SPS Cap Badge</b>	<p>With the formation of the Gurkha SPS company in Jun 11, the Committee had been asked to approve the design of a new cap badge. The Committee had already seen preliminary designs and had provided guidance and advice. The Committee agreed that the design shown below followed all the advice and noted that the College of Arms was content. The Committee therefore approved the design without further comment and asked the Secretary to pass the design formally to the College of Arms for the approval of The Sovereign.</p>  <p><b>Decision.</b> Approved by ADC. <b>Decision 4232</b></p>	HQ BG  HQ AGC  Sec ADC
<b>Item 7. Senior Officers Dress</b>	<p>At the last ADC meeting, the issue of the apparent disregard of General Staff (GS) dress regulations by senior officers of the Army was discussed. The Army Historical Advisor was invited to review what was fundamental to GS Dress Regulations in order to ensure consistency of dress among senior officers and proper use of the various promotion grants. He and the Secretary presented the options which were:</p>

	<p>a. Do Nothing  b. Reinforce existing regulations  c. Allow Colonels to continue to wear regimental and corps dress but with GS accoutrements ie forage cap, cap badge and gorgets with an option to wear the GS Mess Kit (at their own expense) or their previous corps mess kit. Brigs and General Officers would wear the full GS uniform according to the existing regulations but would be provided with an adequate promotion grant to cover the essential items.</p> <p>The Committee agreed that Option A was not feasible as many senior officers were drawing the promotion grant but not wearing the correct dress either out of ignorance or because they chose to ignore the regulations. This could lead to accusations of fraud. The Committee also noted that the current promotion grants were totally inadequate and did not match the requirements of dress regulations. Therefore if Option B was selected, additional funding would be required which would be very unlikely to be forthcoming, very difficult to substantiate in the current financial climate and undoubtedly would lead to adverse publicity.</p> <p>The Committee therefore agreed that Option C was both feasible and logical. The Committee noted that promotion grants could be re-aligned to provide the essential items for each rank within the existing funding. If this option was supported by CGS, detailed dress regulations and guidance on dress would be provided to each officer on promotion to and within the General Staff.</p> <p>The Chairman asked the Secretary to provide him with a brief recommending Option C for CGS' endorsement</p>	Sec ADC
<b>Item 8. R IRISH Stable Belt and TRF</b>	<p>The R IRISH Dress Committee proposed changes to the authorised designs of their stable belt and TRF as shown below. The Committee was reluctant to approve the changes as the Committee felt that recognition of antecedent regiments that were shown in the existing authorised belt had been lost and both the belt and TRF were too focused towards the 1<sup>st</sup> Bn's role with 16 Air Asslt Bde. The Committee also felt that the belt was too similar to the RIFLES stable belt.</p> <p>The Committee therefore asked to view actual examples of both the belt and the TRF at the next meeting and for the Sec to find out the views of the RIFLES.</p>	RHQ R IRISH Sec ADC

<b>Item 9. MPGS No 2 Dress Accoutrements</b>	<p>HQ AGC (SPS) had put forward a proposal at a previous meeting for designs for MPGS collar badges and buttons for No 2 Dress. The Committee did not wish to approve designs for accoutrements for an order of dress that the MPGS were not authorised to wear. However the Committee learned that HQLF Log Sp had agreed to sell a pool of 50 No 2 Dress uniforms to HQ AGC (SPS) at non-public expense and to reduce costs, HQ AGC (SPS) had decided that MPGS would wear standard SPS buttons. <b>Item 10. AGC AWW TRF &amp; Rank Slides</b>	<p>Army Welfare Workers (AWW) currently wear the AGC(SPS) variation of TRF and rank slide. This has led to some confusion, in particular with patients at RCDM and DMRC Headley Court, in that AWW are being asked Cbt HR Spec type questions which they are unable to answer. HQ AGC (SPS) proposed that AWW wore a different TRF as shown below with the words "AWW" on their rank slides to differentiate them from others. <p>Item 11.  <b>Household Cavalry Mounted Regiment No 2 Dress Breeches</b></p>	<p>The Committee heard that the military issued breech for all Mounted Troops Other Ranks has been in service for over 30 years. Many HCMR personnel found them uncomfortable to wear as the fabric became abrasive, change colour and stretched in the seat after washing and continual use. The “comfort fit” of the new FAD No 2 Dress jacket was welcomed but the smarter appearance of the FAD jacket was ruined by troops on parade wearing a multitude of coloured breeches; this was considered unacceptable as troops spend most of their time in this order of dress. HCMR soldiers (up to WO2s) were issued with 2 x pairs of breeches but many were exchanged within 5 months of issue due to shrinkage and colour degradation issues.</p> <p>HCMR proposed a new design of breeches with different material from a number of designs from commercial sources. HCMR had trialled 2 that were the most suitable and found that they showed no colour change or stretching and were far more durable. One particular design had been approved by both CO HCMR and Silver Stick. However, while the Committee noted that King’s Tp RHA were content with the current design, HCMR was the majority user and therefore the Committee approved both the design and the material of the commercial breeches. The Committee stressed that the preferred option for procurement must be by a formal contractual arrangement through DC T.</p> <p>Existing stock levels of the current pattern were sufficient for some 9 months usage. Preliminary discussions to be arranged between Land and DC T to agree/amend DC specification for breeches and formalise commercial approach. Timescales for subsequent supply to be confirmed at next ADC. <b>Item 12. FAD Update</b>	<p>HQLF Log Sp reported that all sizing packs were now under the control of Divisional G4 staff. To date some 45,000 uniforms (No 2 Dress and barrack dress) had been issued to the Fd Army and a further 21,000 issued by ITG. HQ ITG was now issuing barrack dress to those leaving Phase 1 training. TA units were now appearing in the issue programme with the Regular Army due to be completed by the end of 2011. As a result, the Chairman directed that no old-style No 2 Dress uniforms were to be worn by anyone in the Regular Army after Jan 2012 except for those about to retire or due to be discharged from the Regular Army. The Chairman suggested that such direction should be issued by DGLS&amp;E but asked AD Log Sp for advice.</p> <p>DG Pers announced that he had recently made £30,000 available to start the trial of 300 FAD raincoats provided that the funding could be formally committed within the FY. DC T expressed concern that there was insufficient time to follow the normal commercial procedures but there may be ways to procure a suitable raincoat using existing workwear contracts. While the Committee had previously endorsed a design, colour and material for the FAD raincoat, the Committee felt that such was the need for the trial of a raincoat, that if an existing raincoat could be adapted and procured within the FY, it would be preferable to no raincoat at all. The Secretary was asked to produce an SUR to start the procedure. The Parade and Ceremonial Manager said that while raincoats were not his department's responsibility, he would investigate the best means of procuring the raincoat for the trial.</p>	All Regtl/Corps HQ  HQLF Log Sp  Sec ADC  DC T
<b>Item 13. Items for Discussion</b>	<p><b>a. Personal Clothing System (PCS).</b> COS DC T briefed the Committee on the introduction of PCS and the associated Personal Loading Carrying (PLC) system and body armour which together made up PECOC. PCS was an evolutionary design from CS95 with Multi Terrain Pattern (MTP) material and would be introduced before the associated PLC. He described the items that made up the PCS which would be available for operations and training from Apr 11. According to the current funding profile, CS95 would be withdrawn from issue by end of FY 2012. Therefore there would be a "mixed fleet" of combat uniforms during 2011/12 although this would not occur at unit level as issues would be on a unit by unit basis.</p> <p>It was noted that uniforms currently worn in Afghanistan are a transitional uniform based on CS95 but fabricated in</p>	All Regtl/Corps HQ

	<p>MTP material. COS DC T mentioned that MTP was commercially protected by the MOD and no licenses would be issued. As a result, individuals and PRIs would not be able to source personalised items such as MTP rank slides with regimental/Corps abbreviations. Rank slides worn with PCS would therefore be the issued rank slide with no regimental/Corps indicator or a privately purchased rank slide in a contrasting material. There was concern from HQLF that individuals would cut up parts of their issued uniform so that they could source the MTP cloth for other purposes. This was considered a matter for the chain of command to prevent.</p> <p>There was discussion about the angle that badges would be attached to the pocket on the arms of the PCS smock as the pocket is angled to enable easy access. If badges were attached square to the pocket, they may appear at an odd angle to the observer. PS12 (A) and COS DC T were asked to provide appropriate direction.</p> <p>b. <b>Funding of TRFs and Formation Flashes.</b> The Chairman stated that the clothing and ancillary items that was provided in the “black bag” for operations was widely recognised as being of excellent quality and there were no essential items that soldiers felt they had to provide from their own pockets. However TRFs and Formation Flashes were required on all Combat Uniforms but were not provided at public expense. While not expensive, the fact that individual soldiers had to purchase an item of clothing that they had been ordered to wear was becoming a source of increasing irritation. Item 14. Any Other Business	<p>a. <b>Update on OP BRIDGE Clothing.</b> The Secretary stated that all manning tasks for the most man-power intensive OP BRIDGE had now been allocated which allowed those Corps and Regiments concerned to pre-position all uniforms and accoutrements. This allowed for quick reaction and significantly reduced the tailoring effort on HQ LONDIST. As a result, all Army personal on parade for any BRIDGE operation and in the public eye would be dressed in No 1 Dress (and greatcoats during winter months) which had been the previously stated aspiration of the ADC.</p> <p>b. <b>Poppies.</b> After the recent Remembrance Day activities, it had been noticed that poppies worn in support of the Earl Hague Fund and the RBL were being worn by Army personnel in uniform in a variety of ways. The Secretary was asked to produce clear direction in time for next year's activities.</p> <p>c. The Chairman placed a date of 1<sup>st</sup> Apr 09 as the target date. [REDACTED] [REDACTED] as the Female Focus agreed to provide any assistance and comment.</p> <p><b>Item 12b. REME Qualification/Employment Badges.</b> At the last ADC, the Chairman asked for a comparison of the current regulations concerning the wearing of the Hammer and Pincer badge and HQ REME's proposed changes. After a brief discussion, HQ REME's proposals were accepted.</p> <p><b>Decision.</b> Approved by ADC. <b>Decision 4181</b></p>	Sec ADC Sec ADC Sec ADC Sec ADC
<b>Item 3. Record of OOC Decisions</b>	<p>There had been 1 Out of Committee Decision since the last ADC meeting.</p> <p>a. <b>Uniform Grants.</b> The review of Uniform Grants had been completed. It had been circulated out of committee and agreed by the Chairman and all committee members. Subsequently the Chairman had signed a letter to A&amp;SDs and the chain of command outlining the reasons behind the review and the new figures. For the record, a copy of his letter is attached to these minutes at Annex A. There was comment that the non-standard Sam Browne grant of £180 was inadequate for some regiments particularly RIFLES and RGR. After a short discussion, it was agreed that uniform grants could not be split into individual regiments and corps and noted that some other regiments' belts cost significantly less than the grant.</p> <p>b. The figures for all grants were ratified and are reproduced at Annex B to these minutes for the record.</p>

<b>Item 4. No 1 Dress Trouser Striping</b>	<p>a. It was noted that all the corps and regiments as well as RMAS who currently wear a broad crimson stripe on Full Dress and No 1 Dress had agreed to move to a 1<sup>7</sup>/<sub>8</sub> inch crimson stripe provided that there would be grandfather rights on the old striping. It was noted that RMAS wished to convert the whole Academy at one time. The Committee agreed that the following corps and regiments as well as RMAS would move to a 1<sup>7</sup>/<sub>8</sub> inch crimson stripe on Full Dress and No 1 Dress: RMAS, RA, R SIGS, RE, RRF, AAC, REME, AGC and APTC.</p> <p><b>Decision.</b> Approved by ADC. <b>Decision 4183</b></p> <p>b. However DC IPT pointed out that a flat fronted trouser required more tailoring to fit a broad range of sizes and therefore could be more costly than a pleated trouser. All agreed with the Historical Advisor that the flat fronted trouser was historically correct and the committee wished to keep to historical accuracy. However DC IPT was asked to report back if the additional tailoring costs associated with a flat fronted trouser were likely to be greater than the saving from rationalising the size of the crimson striping.</p>	Sec ADC  DC IPT
<b>Item 5. Aiguillettes and the Royal Cypher.</b>	<p>a. Sec ADC explained the rationale behind the review of entitlements to wear aiguillettes and the Royal Cypher outlining some principles that he had deduced from a study of the 3 Services current entitlements. Using these principles, he had drawn up a new list of entitlements covering all 3 Services that removed the anomalies. He had articulated these principles and anomalies with recommendations as to how they might be overcome in a draft letter to the Lord Chamberlain's Office. While the Committee agreed to the Army's list of entitlements, it was noted that the RAF in particular might not agree to the loss of rights for senior RAF officer's as Administrators of the Sovereign Base Area Cyprus. Therefore the Chairman directed that formal agreement to the revised lists of entitlements from both the RN and the RAF should be received before the letter was passed to the Lord Chamberlain's Office.</p>	Sec ADC

The Committee considered the crest to be very badly designed; the phoenix was poorly represented, in heraldic terms it is inappropriate to have numbers so prominent and mottos should not be left floating but surrounded by a banner of some sort. Most importantly, it was wrong to have the Sovereign's crown subordinate to all other elements of the design.</p>	Sec ADC

**INITIAL OFFICERS' UNIFORM GRANTS – RATE CHANGES**

References:

- A. Regulations for Army Allowances and Charges Chapter 15 Annex A.
- B. D/DPS(A)/25/1/1/PS12(A) dated 25 Nov 08.
- C. D/DPS(A)/25/03/00(PS12(A)) dated 8 Jan 09.

**Issue**

1. The development of a number of changes with regard to uniform provision within the Army.

**Officers' Uniform Grants**

2. The introduction of a new all ranks Number 2 Dress has catalysed a review of officers' uniform allowances, some of which have not been updated for many years. The extant authority to pay officers' uniform allowances remains Reference A which will be re-written in the next month. However, I need to inform you of the changes to the initial grants now in order to synchronise them with the release of the new issued Number 2 Dress to the Royal Military Academy Sandhurst (RMAS).

3. The new rates, which the Army Dress Committee approved at References B and C, reflect a number of factors:

a. Direct Entry (DE) Officer Cadets entering RMAS from April 2009 will be issued with the new Number 2 Dress uniform, thereby removing the requirement for them to purchase Number 2 Dress from their Initial Officers' Uniform Allowance.

b. Future Infantry Structures have resulted in amalgamations of regiments and consequent changes to uniforms. Concurrent with this, the range of uniform available to be issued, negating the requirement for private purchase, has increased. This is particularly true for the Royal Regiment of Scotland.

c. Most significantly, the original Initial Officers' Uniform Allowance has not increased since 1994. The rate has been insufficient to fund the uniform required of a newly commissioned officer for some time. The results have been that most young officers have incurred significant personal expense. Even when the Number 2 Dress

requirement is removed, the revised Initial Officers' Uniform Grant (see para 4a) will only just cover the privately purchased uniform requirements of a newly commissioned officer.

4. **Revised Grants.** The initial grants payable on commissioning will now be:

a. **Initial Officers' Uniform Grant.** The Initial Officers' Uniform Grant replaces the former Initial Officer's Uniform Allowance; its name is designed to reflect the one-off nature of payment. It will be paid tax free on commissioning to all Regular Army Officers, DE and Late Entry (LE) alike. For most officers the grant will be £2122. Officers commissioned into regiments which do not require the purchase of a peaked forage cap will receive slightly less<sup>1</sup>. Officers commissioned into the SCOTS will receive a unique rate because their uniform requirements differ significantly from all other cap-badges. Annex A to this letter shows the new rates for the Initial Officers Uniform Grant.

b. **Non-Standard Sam Browne Grant.** Whilst the issued Sam Browne will be suitable for most regiments and corps, certain cap-badges require a non-standard Sam Browne. Officers commissioned into the cap-badges listed at Annex B to this letter will be entitled to claim an additional grant of £180 to contribute to the purchase of a non-standard Sam Browne.

5. **Timing.** The revised Initial Officers' Uniform Grant and Non-Standard Sam Browne Grant will become effective as follows:

- a. **DE Officers.** Officer Cadets and Professionally Qualified Officers (PQOs) entering RMAS from 1<sup>st</sup> April 2009 will be entitled to the revised rates of Initial Officers Uniform Grant. Those who entered RMAS before 1<sup>st</sup> April 2009 will remain on the old rates of Initial Officers' Uniform Allowance.
- b. **LE Officers.** LE Officers commissioned from 1<sup>st</sup> April 2009 will be entitled to the revised Initial Officers' Uniform Grant.

While Officers are at RMAS on both the old and new rates, there could be occasions where individuals commissioning together will have received different sums. While this is not ideal, having examined all the transition arrangements, I am clear this is the best option.

#### **SNCO's Mess Dress Grant**

6. A grant for the purchase of SNCO Mess Kit will be available for all newly promoted Sergeants with effect 1<sup>st</sup> April 2009

7. The grant will be paid as a one-off grant for all Corporals promoted to acting or substantive Sergeant. It will also include Lance Corporals of Horse and Lance Sergeants when appointed to the Warrant Officers and Sergeants' Mess in Household Division units. The grant is for regular Service personnel only and does not include the Territorial Army. There will be 3 different rates as follows:

8. While it would be desirable to have some retrospective element to this new grant, that is not possible. Nevertheless, the provision of this grant for all those promoted after 1 Apr 09 is a considerable improvement to previous conditions of service and is a key part of the strategy to re-enfranchise middle-management. It will be the subject of an IC Campaign once the final points of detail have been agreed.

### The Future

9. The rationalisation of the officer allowances into the Initial Officers' Uniform Grant has brought a logic and robustness to an area where this was previously lacking. The provision of a grant to reflect the cost of purchasing Mess Dress on promotion to SNCO rights a long standing issue. There is more work being undertaken on, for example, TA uniform grants; this will be promulgated shortly.

**[REDACTED] : remarks upon standing down as Historical Adviser at ADC meeting 23 Feb. 2009**

I have been advising this committee for 35 years, slightly over half my lifetime. When I was first asked to do this, the Army Dress Committee had never previously had regular historical advice and, I can tell you, there were occasionally some fascinatingly far-fetched assertions from regiments pressing for what they wanted!

I am very grateful to the ADC for listening to, or reading, my advice over these many years and particularly for quite often deciding to accept the case I was making. On many occasions we have together been able to avert threats to important historical features.

To me the British Army's uniquely fine historic heritage of uniforms and insignia is a valuable, if small, part of our National Heritage, fully equal to a group of Grade I Star Listed buildings.

I wish I could say that our traditions are as well protected as those of the U.S. Marine Corps. I wish I could at least say that the major traditions are safe. Instead I feel the final service I can do is to draw your attention, in an entirely helpful spirit, to what serious harm to the heritage is sometimes allowed to come through the Army's systems. If I may, I'll mention just two fairly recent examples:-

Obviously no one would deny Grade I Star Listed status to the kilt. Within the army itself the black buttons of Rifles must be regarded as equally sacred. So, too, should be the hugely historical emblems of mounted status. Mounted status is the visible essence of cavalry, artillery and a few corps. The keynote items are: overalls and box spurs and blue cloaks (as opposed to infantry grey greatcoats).

A short while ago I saw a party of Royal Artillery doing public duties in Windsor in No. 1 Dress. They were led by an officer with drawn sword, gold pouch belt, and flapping trousers in lieu of overalls!

Yet Dress Regulations are peppered with crystal clear statements of the obvious, namely instructions that Cavalry, Artillery and mounted corps officers are to wear overalls and box spurs in No. 1 Dress.

Regarding the other shock, we have of course discussed cloaks and greatcoats in the Army Dress Committee and I would fully, if sadly, acknowledge that the ruthless timing pressures of Bridges mean correctness must be ruled out for such a large and temporary demand.

However, I had believed that at least the bands, as permanent units known for their splendid and cherished full dress uniforms, could be preserved as beacons of correctness, to represent each of the major elements of the Army properly.

So you can imagine my shock two years ago on seeing the Royal Logistic Corps band in Full Dress at a Sovereign's Parade wearing infantry grey greatcoats in place of dark blue, their correct colour, which they had worn until shortly before.

In the days of khaki greatcoats for everyone the problem did not arise. However, I cannot exaggerate how deeply, almost offensively, wrong it is, in terms of tradition, for any of the handful of bands representing Cavalry, Artillery and mounted corps to wear the grey greatcoat of infantry in lieu of the dark blue cloak that is a key part of their own historic "mounted" image.

The principle of moving from the (at least broadly) correct to the painfully incorrect horrified me, because it shows that even fundamentals are not secure.

So, in standing down, may I leave with you a plea for the army to create some watertight system that can avoid all such possible serious losses to the Army's heritage.

Turning from "shop" matters to personal, I must say how extraordinarily and outstandingly kind all the people I have worked with here have been. Perhaps the most consistent feature of my long time with the ADC has been the very affable and friendly attitude of everyone. Thank you all, including of course [REDACTED] and [REDACTED], for your kindness over the years.

**AUTHORISED No. 11 Dress (Tropical Mess Uniform)**

No. 11 Dress is the Mess uniform of the British Army in warm weather zones worn by Officers, SNCOs and Corporals at their own expense.

**Headdress**

The caps which may be worn with No. 11 Dress are:

- Forage Cap (No. 1). This is the normal headdress.
- Side Hat. This may be worn informally and at the Commanding Officer's discretion.

**Mess Jacket**

All ranks wear a white cotton drill jacket, with a white roll collar, and white infantry pattern cuffs to the same design as officers' No. 10 Dress. The inner ends of the white drill shoulder straps are to be stitched down. There are no buttons worn on this jacket.

**Rank Badges**

Officers wear gilt or anodized badges of rank on the shoulder straps. WOs/NCOs wear gold lace chevrons and/or embroidered gold crown or Royal Arms on green backing.

**Collar Badges**

All ranks wear an inward facing pair of embroidered Regimental cap badges on the lapels.

**Cummerbund**

A Brunswick Green silk cummerbund is worn by all ranks.

**Trousers**

All ranks wear the appropriate No. 10 Dress trousers or overalls - Infantry Pattern. In especially hot climates, trousers of white cotton drill may be worn on the direction of the Commanding Officer.

## **Shirt**

Officers and WO1s wear a piqué fronted white dress shirt.  
WO2s/NCOs wear a plain white shirt.

## **Tie**

A black, silk, double-ended tie of medium width is worn for all formal functions.

## **Footwear**

Officers and WO1s should wear Mess Wellingtons (boxed for spurs).  
Spurs should be worn by Field Officers and Adjutants.  
NCOs wear George boots.

**THE BAND OF THE YORKSHIRE REGIMENT**

**AUTHORISED DRESS REGULATIONS FOR FULL DRESS**

**OFFICERS**

**1. Helmet.** Infantry Officer Universal Home Pattern cloth helmet, with gilt metal fittings, as per Dress Regulations for the Army, 1934, Para 739. Cork covered with very fine dark blue cloth made with four seams (two on each side); above the peaks and encircling lower part of helmet a blue cloth band  $\frac{3}{4}$  inch wide; pointed front peak, with gilt metal edging; a convex bar of gilt metal down centre of rear of helmet; back peak, slightly squared off, with narrow edging of patent leather or similar; on either side is a rose boss  $1\frac{1}{8}$ " in diameter to which is attached (extending from the near side) the curb-chain chinstrap, the gilt metal chain links  $\frac{5}{8}$ " wide and sewn onto black patent leather and lined with black velvet, worn around the helmet; on the top, a gilt metal spike  $2\frac{3}{4}$ " high screwed into a metal cross-piece mounting with hook at rear.

**2. Helmet Plate.** Gilt plate as per Dress Regulations for the Army, 1934, Para 740, consisting of an eight-pointed star with top point displaced by the St. Edward's Crown bearing a circular laurel-wreath; within the wreath a gilt Garter inscribed "HONI SOIT QUI MAL Y PENSE" See note 2. Within the Garter, regimental white rose on a green velvet cloth ground. On the bottom of the wreath is mounted a narrow silvered scroll bearing the title of the regiment. The bottom point of the plate comes halfway over the cloth band of the helmet.

**3. Director of Music Tunic.** Officer pattern. Scarlet cloth, with Brunswick Green facings. The collar  $2\frac{1}{2}\frac{1}{4}$ " high ornamented with  $\frac{5}{8}$ " gold Rose pattern lace along the top and ends, and  $3\frac{1}{16}$ " gold Russia braid along the bottom, with embroidered Regimental No 1 Dress collar badges positioned with their centres  $2\frac{1}{2}$ " from the ends of the collar. The cuffs pointed, trimmed with  $\frac{5}{8}$ " gold Rose lace round the top which extends to  $7\frac{1}{2}$ " from the lower edge of the cuff at the point (note 2) and  $2\frac{1}{2}$ " at the back inclusive of lace. There is a tracing of  $\frac{3}{16}$ " gold Russia braid  $\frac{1}{8}$ " clear above and below the lace. The upper tracing forms an Austrian knot at the top (the whole ornament extending to  $9\frac{1}{2}$ " from the

bottom of the sleeve) and the lower tracing forms a small upward eye onto the point of the Rose lace. Seven 40 ligne gilt buttons of regimental pattern down the front, plus one flat button in or just below the waist-seam, which is covered by the waist-sash. Two similar buttons at the back at the intersection of the waist-seam with the back-seams. Two almost vertical (slightly diverging) pleats that extend down to the bottom of the skirt. A skirt slash extends inwards from each pleat, each slash forming two points below and bearing a 40 ligne gilt button at each point. The skirt closed behind. The closing seam, edged with white cloth, is midway between the two slashes, with the points of the slashes almost touching it. The tunic-fronts and skirt-slashes (except adjoining the pleats) are also edged with white cloth, all such edging showing not more than  $\frac{1}{4}$ " wide. The collar is edged (outside the lace), with slightly narrower white cloth edging. The skirt lined with white cloth. Three ply twisted round gold shoulder cords with a black trace, lined with scarlet cloth and fastened at the top with a screw fitting 22 ligne regimental button. Silver embroidered Bath Stars/Crowns  $\frac{3}{4}$ " size with coloured tops. See Note 3.

**4. Overalls.** Dark blue cloth with a raised  $\frac{1}{4}$ " scarlet welt down each side-seam and black leather foot straps.

**5. Boots.** George boots. (Preferably patent leather). Plain nickel-plated box-spurs of the standard swan-neck pattern are worn by Field Officers.

**6. Sash.** Infantry Pattern. Crimson silk net waist sash without pleats, backed with leather ( $2\frac{3}{4}$ " wide) with cage bow and tassels worn at left side and extending 4" below the tunic.

**7. Sword slings.** Suspended from a concealed web waistbelt, slings of red morocco leather 1" wide, faced with gold lace  $\frac{7}{8}$ " Infantry pattern gold lace with thin crimson central line; gilt billet studs and oval gilt wire buckles. A hook on the eye at top of the front sling for hooking-up the sword.

**8. Sword and Scabbard.** Infantry Officer's pattern, with nickel-plated

scabbard, worn hooked up.

**9. Sword knot.** Gold lace with acorn tassel, the knot bound tight to the guard with the end of the knot on the outside pointing towards the sword tip.

**10. Gloves.** White cotton wrist.

**11. Greatcoat.** Grey, double breasted [Foot Guards officer's pattern] with regimental buttons. Badges of rank in gold embroidery.

**12. Cape.** Grey, of length to reach to the knuckles, with regimental buttons and with dull red lining.

**13. Frock Coat.** Universal pattern, plain dark blue double breasted with matching shoulder straps; 40 ligne buttons and collar badges. Gold wire embroidered Bath Stars/Crowns with coloured tops. Note 4

#### BANDMASTER (WARRANT OFFICER CLASS 1)

**14. Helmet and Helmet Plate.** As for Officer (See Paras 1 and 2)

**15. WO1 Bandmaster Tunic.** As for Officer (See Para 3 and Note 3) except for rank insignia. Musicians lyre (in gold embroidery on scarlet backing) is worn on right forearm above the braid Austrian knot, with the WO1's badge of rank (in gold embroidery on scarlet backing), above it.

**16. Other Items.** As for Officer (See Paras 4-12) but greatcoat sleeve insignia colouring as for Foot Guards WO1 (BM) greatcoat.

#### BAND SERGEANT-MAJOR (WARRANT OFFICER CLASS 2)

**17. Helmet.** Universal (Home Service) pattern cloth helmet with gilt/gilding metal fittings to the pattern described in Dress Regulations for Warrant and Non-commissioned Officers and Men of the Army 1902, Para 12(a), as subsequently modified: the covering of fine very dark blue cloth

made with four seams (two on each side) and with a  $\frac{3}{4}$ " band of self material encircling lower part of helmet; the front peak rounded, the whole lower edge of helmet bound with patent leather or a plastic substitute. On either side is a rose boss ( $1\frac{1}{16}$ " in diameter) to which is attached (extending from the near side) the curb-chain chinstrap, the links  $\frac{5}{8}$ " wide and sewn onto black leather. Top ornament consists of a spike ( $2\frac{3}{4}$ " high) screwed into a metal cross-piece mounting with hook at rear. See Notes 1 and 5.

**18. Helmet Plate.** Universal Pattern gilt metal plate consisting of an eight-pointed star with its top point displaced by the St. Edward's Crown and bearing a circular laurel-wreath; within this is attached the Helmet Plate Centre consisting of a matching circlet inscribed with the regimental title, 'The Yorkshire Regiment' within the circlet the regimental white rose on a green cloth ground.

**19. WO2 (BSM) Tunic.** Scarlet cloth, with Brunswick green cloth collar, cuffs and shoulder-straps. The collar, approx.  $1\frac{7}{8}$ " high and cut square, is ornamented with  $\frac{1}{2}$ " gold "Bias & Stand" (Universal NCOs' pattern) lace along the top and ends, and  $\frac{3}{16}$ " gold Russia braid at the bottom, with regimental cloth collar badges fixed with their centres 2" from the ends of the collar. The cuffs pointed, bearing  $\frac{1}{2}$ " gold bias and stand lace around the top extending to 6" from the bottom of the sleeve at the point (inclusive of the lace) and  $2\frac{5}{8}$ " at back of cuff. Seven 40 ligne gilt metal regimental buttons down the front (six above the belt and one below it). The skirt with matching lining and closed behind, edged with white cloth not more than  $\frac{1}{4}$ " wide on closing seam, down centre, with a skirt slash at each side extending inwards from two nearly vertical (very slightly diverging) pleats that extend down to bottom of skirt (each slash forming two points below the waist); two 40 ligne buttons at the waist behind and one more at each point of each slash below, the waist buttons being each located at the top of one of the pleats, the centres of these two waist buttons approximately  $3\frac{1}{2}$ " (not more than about 4" apart. The whole tunic front and slashes (but not adjoining the pleats) are edged (piped) with white cloth not more than  $\frac{1}{4}$ " wide, the points of the slashes being approximately  $\frac{1}{4}$ " clear from the white cloth edging of the closing seam, and the bottom of the slashes being about  $\frac{1}{4}$ " clear above the lower edge of the tunic. A brass belt-hook in waist-seam on each side. Shoulder-straps  $2\frac{1}{2}$ " wide at outer end, tapering to 2" level with buttonhole, with end angled to a

point, are edged with 3/16" gold Russia braid on the sides and around the point, and fastened with a 30 ligne regimental button. Scarlet cloth wings, edged all round with ½" gold lace (of "Bias and Stand" pattern as described for collar) and crossed with five diagonally-placed bars of the same lace (running inwards and to the rear). See note 3.

**20. Trousers.** Substantial dark blue cloth with a scarlet cloth welt ¼" wide down each side-seam. Pattern similar to Foot Guards ORs Full Dress, well shaped at the ankle, cut without pleats at waist and fitted with braces-buttons. See note 6

**21. Boots.** George boots.

**22. Sash (Shoulder).** Crimson cotton (WO's pattern) with tassels (worn over right shoulder, the lower end of the tassels level with bottom edge of tunic).

**23. Sword and Scabbard.** Sword, Infantry, Warrant Officer, with nickel-plated scabbard.

**24. Sword knot.** White matt plastic strap and acorn.

**25. Sword-belt.** Heavy, solid (not woven), white matt plastic (to resemble buff leather) 1¾" wide regimental clasp. All metal furniture, including hook and adjustment buckle, to be brass or gilt metal or similar. Sword-slings of the same material as the belt, 1" wide, with metal billet studs. (The longer sword-sling slides on the belt, its upper end being at centre back between the two waist buttons, on which the belt edge rests). See Note 7

**26. Waistbelt-Locket.** Regimental Locket. Gilt or Brass, male/female clasp, with the Yorkshire Rose in the centre and Yorkshire Regiment around the circumference of the female fitting. See note 8

**27. Gloves.** White.

**28. Greatcoat.** Grey, single breasted [former Foot Guards pattern, blue-grey] with regimental buttons. Rank insignia above right cuff in scarlet embroidery on

blue cloth. See Note 9

**29. Cape.** Grey, [blue-grey] of length to reach to the knuckles, unlined, with regimental buttons.

## DRUM MAJOR

**30. Uniform, Sword and Accoutrements.** All items except insignia are as described for WO2 (see Paras. 16 - 28 above) but with the following different or additional features:-

**31. Insignia.** The appropriate regulation insignia are worn on the right forearm of the tunic commencing ½" clear above the cuff lace, the chevrons (about 6" across with point up) being of ½" gold "Bias and Stand" lace and the drum of gold wire embroidery etc., all on scarlet cloth backing. The Lyre badge is not to be worn. On the greatcoat, equivalent insignia are worn above the right cuff, the chevrons being of ½" dark blue worsted lace about 6" across on scarlet cloth backing, point up, and the drum in scarlet embroidery on dark blue cloth. See Note 9.

**32. Drum Major's Embroidered Shoulder-Belt (or "Sash"), Staff (or "Mace") and Cane.** All of customary patterns. The Embroidered Shoulder-Belt (widely known as the Drum Major's Sash) is worn over the left shoulder. It is traditionally of cloth of the regimental facing-colour edged with gold lace, generally fitted with two token drumsticks and embellished with Crown and Royal Cypher, regimental insignia, title-scrolls and battle-honour scrolls etc. in wire embroidery, the lower ends edged with gold fringe and joined together.

**33. Gloves.** White cotton

## BAND COLOUR SERGEANT to MUSICIAN

**34. Helmet and Helmet Plate.** As described for WO 2. See Paras 16 and 17 and Notes 1, 2 and 5.

**35. Musn – C/Sgt Tunic.** As described for WO2 (See Para 18 above) but without the trimming of gold lace and gold braid. Only the scarlet cloth Musicians wings are trimmed (to the same design) but with  $\frac{1}{2}$ " white worsted chevron-weave lace. Apart from the collar badge, the collar and cuffs are entirely plain. See note 3

**36. Chevrons and Badges of Rank and Employment.** Insignia, as per regulations, worn on right upper arm, all on scarlet cloth backing, the chevrons point-down and measuring approx. 6" across, as follows:-

- a. Sergeant and above: Chevrons of  $\frac{1}{2}$ " gold "Bias and Stand" (Universal NCOs' pattern) lace. Any accompanying badges in gold wire embroidery.
- b. Corporal and Lance Corporal. Chevrons of  $\frac{1}{2}$ " white worsted "chevron weave" lace (as on Bandsman's wings) with the standard Lyre badge in regulation (white etc.) worsted embroidery.
- c. Musician. Lyre badge as for Corporal but no chevrons.

**37. Sash (Shoulder), (Sergeant and above only).** Scarlet polyester worsted webbing with tassels (worn over right shoulder, the lower end of the tassels level with bottom edge of tunic).

**38. Trousers, Boots and Gloves.** As described for WO (See Paras 19, 20 and 26 and Note 6).

**39. Waistbelt.** Heavy, solid (not woven), white matt plastic (to resemble buff leather)  $1\frac{1}{4}$ " wide with regimental locket and two separate brass or gilt metal adjustment buckles. (When worn, the lower edge of the waistbelt rests on the shanks of the pair of waist buttons at back of tunic). See Note 7.

**40. Waist belt-Locket.** Regimental Locket. Gilt or Brass, male/female clasp, with the Yorkshire Rose in the centre and Yorkshire Regiment around the circumference of the female fitting See Note 8.

**41. Music Pouch.** Matt white, all of same substantial material as the waist belt,

and with gilt/gilding metal/brass fittings throughout (including plain single-prong buckle, tip and slide on the two-piece belt, which is approx.  $2\frac{1}{4}$  in. wide), the flap of the deep-form pouch (pouch very approx. 7 in. high x  $8\frac{1}{2}$  in. wide) may be fitted with a regimental device. Alternatively, a Music Card Case of similar material may be worn on the waist belt.

**42. Greatcoat and Cape.** As described for WO2 (Paras 27 and 28) except the insignia on the greatcoat. Rank chevrons (point down) of  $\frac{1}{2}$ " dark blue worsted lace about 6" across on scarlet cloth backing are worn 1" clear above the right cuff, crowns being in scarlet embroidery on blue cloth. See Note 9.

#### NOTES

**Note 1.** The shape of an officer's cloth helmet, which is pointed at the front peak and slightly squared off at the back, differs considerably from the OR pattern. The correct Full Dress headdress for the Drum Major and any WO (excluding Bandmaster) as well as the Musicians is the Other Rank's Universal pattern Home Service cloth helmet. The cloth covering is extremely dark blue.

**Note 2.** The small silvered title scroll (located low down on the face of officer's pattern helmet plates) is not considered essential and may be omitted, if necessary, to avoid further expense.

**Note 3.** Pointed cuffs should be cut so that the edge curves to a point (with concave sides to the point of the cuff) as opposed to being simply angled to a point. The Bandmaster's shoulder cords are to be identical to those worn by officers.

**Note 4.** The Frock Coat for Infantry of the Line is of the usual Universal pattern: double-breasted with 40ligne gilt buttons, it is made of plain dark blue cloth and has matching shoulder-straps. It has collar badges but it bears no cord, braid or lace ornamentation whatever. The officer's rank badges are of gold embroidery. The Bandmaster's insignia are of gold wire

embroidery on dark blue cloth backing. The Frock Coat is to be worn with the peaked forage cap but all the other items are as for Full Dress (except re medals).

**Note 5.** For all categories covered by these regulations the peaked forage cap is the only undress headdress that may be worn with Full Dress. Although a peaked forage cap is not a Full Dress headdress, it is occasionally worn temporarily with Full Dress for some limited purpose (e.g. for a Bandstand Concert). This practice does not extend to Directors of Music and WO1 Bandmasters in possession of frock coats, who are to wear the Frock coat (with the peaked forage cap) when soldiers are wearing their forage caps with Full Dress tunics.

**Note 6.** No. 1 Dress trousers are significantly different (in cut and texture as well as the scarlet stripe) and would not be correct for wear in Full Dress.

**Note 7.** Serious replicas of proper Full Dress belts etc. made of solid matt white plastic are a reasonable substitute for the historic whitened buff leather. However, woven belts are not correct for Full Dress.

**Note 8.** Regimental locket. In Brass or gilt if possible as opposed to the silver clasp worn in No2 Dress.

**Note 9.** Note that for greatcoats the chevrons are of the same width of lace ( $\frac{1}{2}$ ") as most army chevrons and not of Foot Guards width (nor of similar construction). The badges, however, are similar to Foot Guards pattern, being of scarlet embroidery on dark blue cloth.

**AUTHORISED SPECIFICATION FOR NO 10 DRESS (REGIMENTAL MESS KIT)  
FOR THE ROYAL YEOMANRY**

**OFFICERS**

1. **Jacket.** Blue cloth, scarlet collar and cuffs. Upright collar, not less than 2 inches nor more than 2½ inches high, cut square at the ends. A loop of narrow silver braid at the base of the collar on the left, attached to a hook on the right hand side, to fasten the jacket across the waistcoat. The jacket edged all round, including the collar, with 1 inch silver Vandyke lace, which forms a dummy at the base of each backseam. The base of the collar trimmed with a row of silver chain gimp, terminating at each end under the lace edging of the jacket. A row of white metal studs down the left hand side of the front of the jacket. The cuffs pointed, edged with silver lace as on the jacket, 6 inches deep (including the lace) at the point and 2½ inches deep at the rear. The lace is padded where it forms a point, crimped below the point and folded at both sides of the backseam, terminating at the base of the cuff. Two small plain white metal half-ball buttons on the outer side of the backseam, above the lace. Shoulder-cords of plaited silver chain gimp, with a small half-ball button at top, lined with blue cloth, bearing full-size badges of rank in gold embroidery.
2. **Waistcoat.** Scarlet cloth; upright collar, approximately quarter of an inch lower than that of the jacket, cut square at the ends and fastened with two hooks and eyes, with a black silk tab behind. The waistcoat fastened down the front with hooks and eyes. A row of white metal studs down the left hand front edge. The waistcoat edged around the collar, down the fronts and along the bottom edges to the side-seams, with ¾ inch silver Vandyke lace. Within the lace, a row of silver Russia braid, forming a row of eyes, and a crow's foot in the lower angles. A light of scarlet cloth, 1/8th of an inch wide, between the lace and the Russia. The pockets edged all round with silver Russia forming three eyes above and below, and a crow's foot at each end.
3. **Netherwear.** Blue overalls, with a double stripe of ¾ inch silver Vandyke lace as on waistcoat. Wellingtons, or George boots, with white metal box spurs. Spurs may be swan-necked or straight-necked, according to squadron custom.

**WOs and SNCOs**

4. **Jacket.** Blue cloth, scarlet collar and cuffs. Upright collar, not less than 2 inches nor more than 2½ inches high, cut square at the ends. A loop of narrow silver braid at the base of the collar on the left, attached to a hook on the right hand side, to fasten the jacket across the waistcoat. The jacket edged all round, including the collar, with 3/8 inch silver Russia braid, which forms a figure of eight at the base of each backseam. The base of the collar trimmed with a row similar Russia braid, terminating at each end under the braid edging the jacket. A row of white metal studs down the left hand side of the front of the jacket. The cuffs pointed, 4¼ inches deep at the point and 2 inches at the rear, edged with silver Russia braid, which forms a crow's foot extending 1½ inches above the point of the cuff, and is folded at both sides of the backseam, terminating at the base of the cuff. Two small plain half-ball buttons on the outer side of the backseam, above the braid. A plain loop of narrow silver round cord, fastened by a small white metal half-ball button, on each shoulder. Badges of rank on right sleeve, in silver embroidery on scarlet backing, with Sqn badge above.

5. **Waistcoat.** Scarlet cloth; standing collar, approximately quarter of an inch lower than that of the jacket, cut square at the ends and fastened with two hooks and eyes, with a black silk tab behind. The waistcoat fastened down the front with hooks and eyes. A row of white metal studs down the left hand front edge. The waistcoat edged around the collar, down the fronts and along the bottom edges to the side-seams, with  $\frac{1}{2}$  inch silver "Bias and Stand" lace, the pockets all round with silver Russia forming a loop at each end.

6. **Netherwear.** Blue overalls, with a double stripe of  $\frac{3}{4}$  inch scarlet cloth. Wellington or George boots, with white metal swan-necked box spurs.

Item 5. An element of these T&amp;CS was a uniform maintenance allowance to support their ongoing representational duties. However over time, the amount of this allowance and the mechanism by which it was paid had been lost. DCDS Pers Allowances had agreed that it was a single Service matter and therefore the Secretary was recommending that the amount should be tied to the actual cash benefit received by a serving senior officer through his income tax relief for uniform maintenance. Currently the senior officer income tax relief stands at £749.89 which provides a cash benefit of £299.96 (40% of £749.89). **UPDATE ON PERSONAL OPERATIONAL COMBAT CLOTHING (PECOC)**

1. PECOC clothing represents an evolution rather than a radical change from CS95. Weights of cloth will be the same. The notable features are:
  - Trousers – as CS95 but with angled map pockets on the thighs and a reinforced seat. Some minor “tweaking” but nothing fundamental.
  - Lightweight Jacket/Shirt – Removal of Breast Pockets and Buttons in order to allow integration with Body Armour. Buttons replaced with Velcro to prevent chafing; pockets replaced with internal Map Pockets. Notched collar replaced with cowl collar that can be done up around the neck to prevent chafing of the neck by body armour. Sleeves to have UBACS style sleeves (ie pockets for forearm and elbow padding/protection and bicep pockets to allow storage of small items/1<sup>st</sup> aid when chest pockets cannot be accessed. Velcro to Bicep Pocket to allow interchange of TRFs/Qualification Badges etc with Combat ID. Bicep Pockets positioned to allow RM/RAF Regt Shoulder Titles. Velcro on Bicep Pockets allows correct positioning of qualification badges and TRFs.
  - Smock – no significant change to current CS95 Windproof but with additional technical features such as underarm zips, shrouded buttons, handwarmer pockets etc. Will also have Bicep Pockets as per Shirt. (NB Aim is for commonality of stowage no matter whether UBACs, Lightweight Jacket/Shirt or Smock are being worn.
  - All will be in MTP
2. These items were briefed to the LF Command Board and were accepted. There was some discussion with “should shirts be in our out?”. The LF Command Board view was that Shirts Out was the preferred option although they recognised that ADC and the Chains of Command would have a view. It is our intent to subsequently adjust the spec of the Lightweight Jacket/Shirt so that it is more tailored, making it look smarter when worn out.
