### NOTICE TO TRADERS 01/19

#### Information for businesses with tariff quota licences

#### What will happen to your non-preferential WTO tariff quota licence(s) if the UK leaves the EU without a deal?

##### Introduction

Delivering the deal negotiated with the EU remains the Government's top priority. This has not changed.

The Government is accelerating 'no deal' preparations to ensure the country is prepared for every eventuality. It is the responsible thing to do. Businesses and citizens should ensure they are similarly prepared.

This notice provides up-to-date information for those with current tariff quota licences, issued by the RPA.

##### Tariff Quota Licence Validity

If you hold a non-preferential, WTO tariff quota import licence from the RPA, this will be invalid for importing goods into the EU after 29 March 2019.

However, if you hold a non-preferential WTO tariff quota import licence which was issued before 29 March and is valid beyond that date, you will still be able to import goods into the UK.

Details of the licences – by order number – that will be honoured after 29 March are listed in Annex 1 of this notice.

The RPA will provide you with information, in due course, clarifying how the following licences will be affected in a 'no deal' scenario:

- Preferential tariff quota import licences, and;
- Tariff quota export licences.

We will also provide you with guidance about the return of RPA-issued licences.
