Thank you for your email received on 9 August 2019 requesting the following information:

“My freedom of information request is that of data regarding casualties varying in their roles. In this I mean, the amount of people who died as a result of combat but organized as how many people from each rank (private-Field Marshal (although I doubt anyone of the rank of field marshal was killed)) and then again organized by regiment. And if possible organized by both at once. (Replace regiments for branches etc for the navy and RAF)”

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

The Ministry of Defence requires further information in order to determine whether it holds information within the scope of your request. In particular, we need to know the date period you require information for. For example combat deaths since 2006.

Once you have clarified your request, I will be pleased to consider it again.
