FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: OFFICER AND STAFF CONVICTIONS.

We refer to your email dated 16 September 2019 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

**“Please supply me with officer and staff conviction data broken down as follows:
The number of staff and officer convictions, for the years of 2008 and 2018 (Jan 1 - Dec 31 of both years) listed by the year of conviction, the offence and the outcome.”**

If your records do not go back as far as 2008 then I will accept the earliest year you have records for after 2008 and 2018 (the years between are not being requested).”

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

No convictions have been recorded for Non Uniform Civil Servants.

The Data below is for current Police Officers from 1 January 2013 :

Year	Offence	Outcome
2015	Traffic speeding	6 penalty points on licence - £525 fine
2016	Traffic speeding	6 penalty points on licence - £321 fine

2018	Traffic Speeding	Disqualified from driving for 14 days - £508 fine
2018	Traffic Speeding	Disqualified from driving for 4 months - £230 fine
2018	Traffic - Careless driving	8 penalty points on licence - £3000 fine
2018	Traffic - speeding	6 penalty points on licence - £681 fine
2018	Criminal damage	Conditional caution
