

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

Kent County Council

(Bridleway EE488 at Goodnestone & Eastry) Definitive Map Modification Order 2019

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **03 March 2020**

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding a length of public bridleway numbered EE488, which commences at its connection with Knowlton Lane (point A) and runs south-east through to east for 502 metres, to public footpath numbered EE261 at NGR TR 2863 5332 (point E). Between the points A-B-C-D-E on the Order plan.

The effect of the Order is also to add a further length of public bridleway numbered EE488, which commences at its connection with Thornton Lane (point G2) and runs east through to east south-east for 931 metres to its connection with Pike Road (point I), then from the east side of Pike Road (point J) for 443 metres to the A256 (point K), and then from the east side of the A256 (point L) for 229 metres to Straight Mile (point M). Between the points G2-H-I-J-K-L-M on the Order plan.

The effect of the Order is also to upgrade the entire length of public footpath EE261 to public bridleway status and re-number it to EE488, which commences at the aforementioned point E and runs east to Thornton Lane (point G1). Between the points E-F-G1 on the Order plan.

All distances are approximate, all directions are general.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 17 March 2020]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 28 April 2020]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 09 June 2020]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

DEFINITIVE MAP MODIFICATION ORDER 2019**

This Order is made by the Kent County Council ("the Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that map sheets 165 (TR25SE) & 177 (TR35SW) of the Definitive Map and Statement for the County of Kent requires modification in consequence of the occurrence of an event specified in 53(3)(c)(i) & (iii), namely the discovery of evidence by the Authority which shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to such that the land over which the right subsists is a public path or a restricted byway or, subject to section 54A, a Byway Open to All Traffic; and the discovery of evidence by the Authority which shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The Authority has consulted with every local authority whose area includes the land to which the Order relates.

The Kent County Council hereby orders that:

1. For the purpose of this Order the relevant date is 1st February 2019.
2. Sheets 165 (TR25SE) & 177 (TR35SW) of the Definitive Map for the County of Kent and its associated Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "*The Kent County Council (Bridleway EE488 at Goodnestone & Eastry) Definitive Map Modification Order 2019*".

PART I: MODIFICATION OF DEFINITIVE MAP

Description of path to be added

The effect of the Order is to add a length of public bridleway numbered EE488, which commences at its connection with Knowlton Lane at NGR TR 2815 5337 (point A) and runs generally south-east through to east for approximately 502 metres, to where the existing public footpath numbered EE261 commences at NGR TR 2863 5332 (point E). Between the points A-B-C-D-E on the Order plan.

The effect of the Order is also to add a further length of public bridleway numbered EE488, which commences at its connection with Thornton Lane at NGR TR 2937 5323 (point G2) and runs generally east through to east south-east for approximately 931 metres to its connection with Pike Road at NGR TR 3028 5312 (point I), then from the east side of Pike Road at NR TR 3031 5313 (point J) for approximately 443 metres to the A256 at NGR TR 3072 5300 (point K), and then from the east side of the A256 at NR TR 3078 5298 (point L) for approximately 229 metres to Straight Mile at NGR TR 3100 5291 (point M). Between the points G2-H-I-J-K-L-M on the Order plan.

Schedule of widths:

Between points A-B: 11.0 metres;

Between point B-C: 7.0 metres;

Between points C-D: 7 metres for the first 37 metres narrowing to 4 metres;

Between points D-E: 4 metres;

Between points G-M: 2.5 metres.

Description of path to be modified

The effect of the Order is also to upgrade the entire length of public footpath EE261 to public bridleway status and re-numbered EE488 with a width of 3.5 metres, which commences at NGR TR 2863 5332 (point E) and runs generally east to Thornton Lane at NGR TR 2936 5323 (point G1). Between the points E-F-G1 on the Order plan.

PART II: MODIFICATION OF DEFINITIVE STATEMENT

The Definitive Statement is amended by the addition of the following entry:

EE488 Bridleway

Connections – Knowlton Lane, Thornton Lane, Pike Road, A256, Straight Mile

Added by The Kent County Council (Bridleway EE488 at Goodnestone & Eastry) Definitive Map Modification Order 2019.

Footpath EE261 is upgraded to bridleway and renumbered EE488.

The total length of the bridleway is approximately 2960 metres.

Schedule of widths:

Between points A-B: 11.0 metres;

Between point B-C: 7.0 metres;

Between points C-D: 7 metres for the first 37 metres narrowing to 4 metres;

Between points D-E: 4 metres;

Between points E-G: 3.5 metres;

Between points G-M: 2.5 metres.

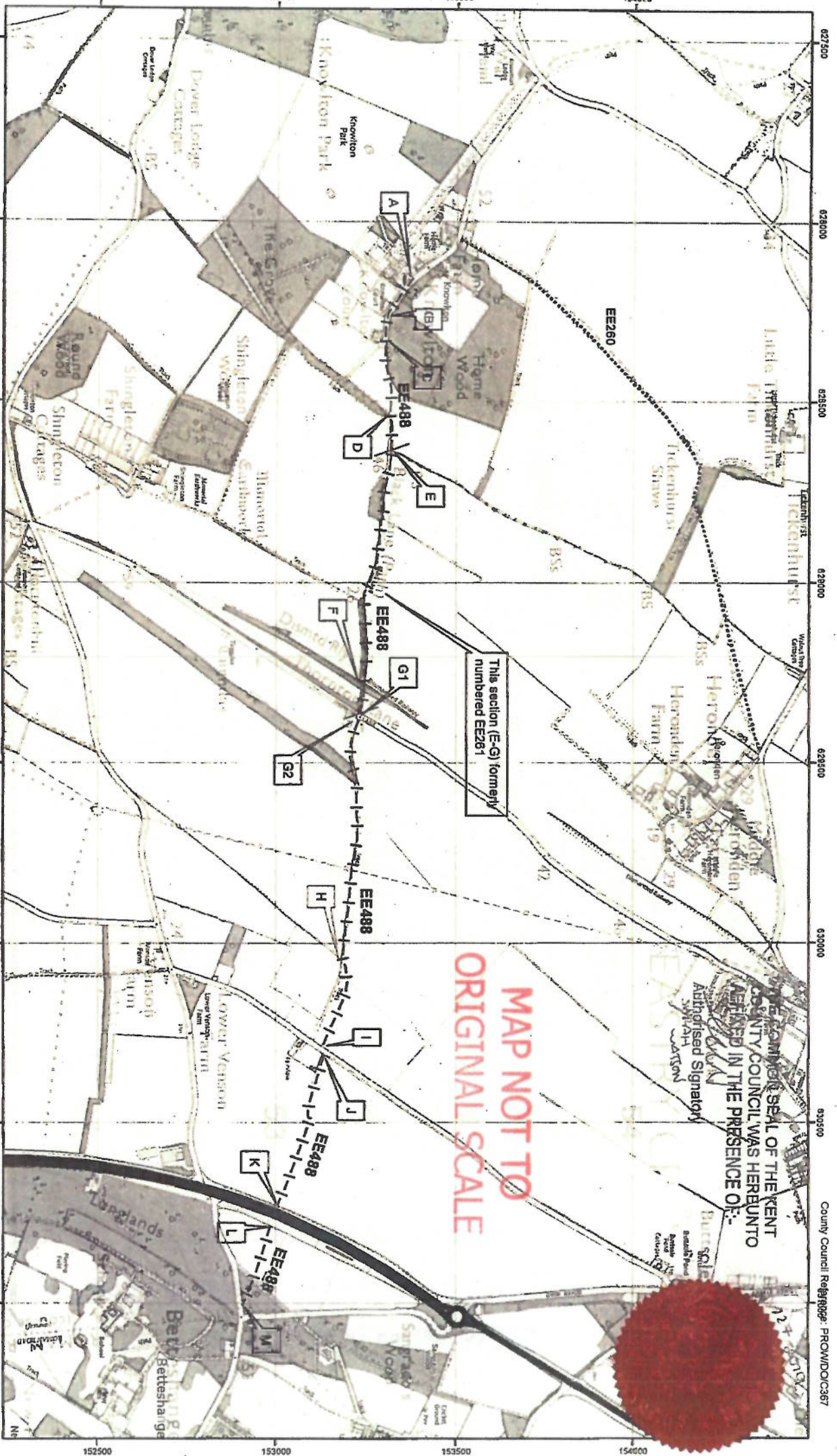
