

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

Norfolk County Council
(Cley-Next-The-Sea, The Hangs) Modification Order 2018

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 27 August 2019.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **Cley Village Hall, The Fairstead, Cley-next-the-Sea, Holt, Norfolk NR25 7RJ** at 10.00am on **Wednesday 12 February 2020**.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding thereto:-

In the Parish of Cley-Next-the-Sea Bridleways

Starts from U4410 Old Womans Lane at grid reference (gr) TG0516 4342 and proceeding generally easterly for approximately 692 metres to gr TG0585 4336. From this point the way turns to run in a generally southerly direction for approximately 266 metres to gr TG0586 4309. From this point the way turns in a generally south easterly direction for approximately 199 metres to gr TG0595 4293 and then in a generally easterly direction for 98 metres to gr TG0605 4293 and then south easterly for 509 metres to meet with the C307 Bridgefoot Lane at gr TG0639 4256. The width of the bridleway is approximately 3.3 metres.

Starts from the A149 Coast Road at grid reference (gr) TG0561 4409 and proceeds in a generally easterly direction for approximately 240 metres to gr TG0538 4408 and then continues in a generally southerly direction for 355 metres and then crosses over a field boundary for 7.6 metres at gr TG0584 4372 and continues generally southwards for 356 metres to gr TG0585 4336. The width of the bridleway is approximately 3.3 metres.

Starts at grid reference (gr) TG0586 4309 and proceeds in a generally easterly direction for approximately 211 metres to gr TG0606 4307 and then continues in a generally easterly direction for approximately 276 metres to gr TG0634 4309. From this point the way turns generally south south easterly for approximately 399 metres to gr TG0649 4273. From this point the way turns generally south westerly for approximately 195

metres to gr TG0639 4275. The width of the bridleway is approximately 3.3 metres.

Limitations and conditions – Bridle gate at gr TG0639 4256.

As Norfolk County Council have indicated that they will not be supporting the Order at the Inquiry, the case for the Order will be presented by Mr Alan Kind. Mr Kind will be expected to adhere to the following timetable as if he were the Council.

Timetable for sending in statements of case and proofs of evidence

Within 8 weeks of the start date by [by 22 October 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 3 December 2019]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an

objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [14 January 2020]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.
