

Anticipated acquisition by Stonegate Pub Company Limited of Ei Group plc

Decision on acceptance of undertakings in lieu of reference

ME/6842/19

The CMA's decision to accept undertakings in lieu of reference under section 73(2) of the Enterprise Act 2002 given on 14 February 2020. Full text of the decision published on 21 February 2020.

Introduction

- 1. Stonegate Pub Company Limited (**Stonegate**) has agreed to acquire the entire issued share capital of Ei Group plc (**Ei**) (the **Merger**). Stonegate and Ei are together referred to as the **Parties**.
- 2. On 6 December 2019, the Competition and Markets Authority (**CMA**) decided under section 33(1) of the Enterprise Act 2002 (the **Act**) that it is or may be the case that the Merger consists of arrangements that are in progress or in contemplation which, if carried into effect, will result in the creation of a relevant merger situation, and that this may be expected to result in a substantial lessening of competition (**SLC**) within a market or markets in the United Kingdom (the **SLC Decision**). The text of the SLC Decision is available on the CMA webpages.¹
- On 13 December 2019, Stonegate offered undertakings in lieu of reference to the CMA for the purposes of section 73(2) of the Act (the **Proposed Undertakings**).
- 4. On 20 December 2019, the CMA gave notice to Stonegate, pursuant to section 73A(2)(b) of the Act, that it considers that there are reasonable grounds for believing that the Proposed Undertakings, or a modified version of them, might be accepted by the CMA under section 73(2) of the Act and that it

- is considering Stonegate's offer (the UILs Provisional Acceptance Decision).
- 5. On 21 January, the CMA issued a notice of consultation on the Proposed Undertakings (the **Notice of Consultation**), set out in Annex 1 below. The Notice of Consultation stated that the CMA would have regard to any representations received, and Stonegate may need to make modifications to the Proposed Undertakings as a result of those representations.
- 6. The text of the SLC Decision,the UILs Provisional Acceptance Decision and the Notice of Consultation (including the Proposed Undertakings) are available on the CMA webpages.²

The undertakings offered

- 7. As set out in the SLC Decision, the CMA found a realistic prospect of an SLC in relation to 51 local areas, specified in Annex 3 of the SLC Decision, as a result of horizontal unilateral effects.
- 8. As set out in the UIL Provisional Acceptance Decision, to address the SLC identified by the CMA, Stonegate has offered Proposed Undertakings comprising a structural divestment of either (i) the individual pub on which a particular catchment area was centred (the centroid pub) (26 instances); or (ii) the entire overlap of the other party (25 instances) in the particular catchment area. In total, this would amount to the divestment of 42 sites to solve the realistic prospect of an SLC in 51 local areas. The proposed divestment will be made by way of asset transfers. Stonegate will group multiple divestment sites into packages rather than selling them individually, ie Stonegate will sell the divestment sites in no more than three packages, save as the CMA otherwise agrees. The text of the undertakings is available on the CMA webpage.³
- As set out at paragraph 17 of the UILs Provisional Acceptance Decision, the CMA does not consider it appropriate to seek an upfront buyer in respect of the Proposed Undertakings.

Consultation

- 10. On 21 January 2020, pursuant to paragraph 2(1) of Schedule 10 to the Act, the CMA published the Proposed Undertakings, inviting interested parties to give their views on the Proposed Undertakings. The relevant text from the consultation is set out at Annex 1 of this decision.⁴ For the reasons set out in the consultation, the CMA's preliminary view was that the Proposed Undertakings would resolve the SLC identified in the SLC decision in a clear-cut manner, ie without giving rise to material doubts about the overall effectiveness of the Proposed Undertakings or concerns about their implementation.⁵
- 11. The CMA did not receive any third-party submissions during the consultation period regarding the substance or scope of the Proposed Undertakings.
- 12. The CMA did receive a small number of third-party submissions from current managers and/or tenants of pubs listed as proposed divestment pubs who wished to make offers to acquire the freehold or leasehold interest of the pub they operated. These third parties were concerned that they would not be considered as potential purchasers for these pubs because of the limitation on the total number of divestment packages.⁶
- 13. The CMA informed these third parties, and Stonegate, that a manager/tenant wishing to buy the property that they are currently operating would constitute one of the circumstances in which the CMA would consider giving written consent to Stonegate to sell the pubs in more than three divestment packages. Therefore, if Stonegate made reasoned submissions regarding the need for additional packages to accommodate sales to existing managers/tenants, the CMA would be minded to agree to increase the total number of divestment packages.
- 14. Accordingly, these third-party submissions did not cause the CMA to change its preliminary view that the Proposed Undertakings would be acceptable.
- 15. The CMA therefore considers that the Proposed Undertakings by Stonegate are clear-cut and appropriate to remedy, mitigate or prevent the competition concerns identified in the SLC Decision.
- 16. For the reasons set out above, the CMA considers that the Proposed

Undertakings provided by Stonegate are as comprehensive a solution as is reasonable and practicable and remedy, mitigate or prevent the SLC identified in the SLC Decision and any adverse effects resulting from it. The CMA has therefore decided to accept the Proposed Undertakings offered by Stonegate pursuant to section 73 of the Act. The Merger will therefore not be referred for a phase 2 investigation.

17. The undertakings, which have been signed by Stonegate and will be published on the CMA webpages, will come into effect from the date of this decision.

Notice under paragraph 2(1) of Schedule 10 to the Enterprise Act 2002 (the Act) – consultation on proposed undertakings in lieu of reference pursuant to section 73 of the Act

Introduction

- 1. Stonegate Pub Company Limited (**Stonegate**) has agreed to acquire the entire issued share capital of Ei Group plc (**Ei**) (the **Merger**). Stonegate and Ei are together referred to as the **Parties**.
- On 6 December 2019, the Competition and Markets Authority (CMA) decided under section 33(1) of the Enterprise Act 2002 (the Act) that it is or may be the case that the Merger consists of arrangements that are in progress or in contemplation which, if carried into effect, will result in the creation of a relevant merger situation, and that this may be expected to result in a substantial lessening of competition (SLC) within a market or markets in the United Kingdom (the SLC Decision). The text of the SLC Decision is available on the CMA webpage.⁸
- 3. On 13 December 2019, Stonegate offered undertakings in lieu of reference to the CMA for the purposes of section 73(2) of the Act.
- 4. On 20 December 2019, the CMA gave notice to Stonegate, pursuant to section 73A(2)(b) of the Act, that it considers that there are reasonable grounds for believing that the undertakings offered, or a modified version of them, might be accepted by the CMA under section 73(2) of the Act and that it is considering Stonegate's offer (the UIL Provisional Acceptance Decision).

The undertakings offered

- 5. As set out in the SLC Decision, the CMA found a realistic prospect of an SLC in relation to 51 local areas, specified in Annex 3 of the SLC Decision and Annex 1 of this Notice, as a result of horizontal unilateral effects.
- 6. As set out in the UIL Provisional Acceptance Decision, to address the SLC identified by the CMA Stonegate has offered a structural divestment of either (i) the individual pub on which a particular catchment area was centred (the **centroid pub**) (26 instances); or (ii) the entire overlap of the other party (25 instances) individually (the **Proposed Undertakings**). In total, this would amount to the divestment of 42 sites to solve the realistic prospect of an SLC in 51 local areas. The proposed divestment will be made by way of asset transfers. Stonegate would group multiple divestment sites into packages rather than selling them individually. The text of the undertakings is available on the CMA webpage.⁹
- 7. As set out at paragraph 17 of the UIL Provisional Acceptance Decision, the CMA does not consider it appropriate to seek an upfront buyer in respect of the Proposed Undertakings based on evidence provided by Stonegate that there are several potential suitable purchasers who have expressed an interest in purchasing the Parties' pubs. The CMA also notes that there are many pub divestments annually in the UK.

CMA assessment

8. The CMA currently considers that, subject to responses to the consultation required by Schedule 10 of the Act, the Proposed Undertakings will resolve the SLC identified in the SLC Decision in a clear-cut manner, ie the CMA currently does not have material doubts about the overall effectiveness of the Proposed Undertakings or concerns about their implementation. The proposed structural divestments are intended to replace the competitive constraint provided by Ei on Stonegate that would otherwise be lost following the Merger in each of the 51 local areas. The name and location of the 42 pubs that Stonegate has offered to divest are listed in the Appendix A to the proposed undertaking that the CMA is now consulting on and in Annex 2 of this Notice.

9. The CMA also considers that the Proposed Undertakings would be capable of ready implementation, because the divestment pubs are stand-alone businesses that are capable of being sold and likely to continue in operation as a going concern.

Proposed decision and next steps

- 10. For the reasons set out above, the CMA currently considers that the Proposed Undertakings are, in the circumstances of this case, appropriate to remedy, mitigate or prevent the competition concerns identified in the SLC Decision and form as comprehensive a solution to these concerns as is reasonable and practicable.
- 11. The CMA therefore gives notice that it proposes to accept the Proposed Undertakings in lieu of a reference of the Merger for a phase 2 investigation. The text of the proposed undertaking is available on the CMA web pages.¹¹
- 12. Before reaching a decision as to whether to accept the Proposed Undertakings, the CMA invites interested parties to make their views known to it. The CMA will have regard to any representations made in response to this consultation and may make modifications to the Proposed Undertakings as a result. If the CMA considers that any representation necessitates any material change to the Proposed Undertakings, the CMA will give notice of the proposed modifications and publish a further consultation.¹²
