Thank you for your email of 17 December in which you requested the following information:

"Please can you tell me the Course phases and their lengths in weeks for Class 3 and Class 1 training courses for the following Royal Signals Roles

Information Services Engineer Networks Engineer Infrastructure Engineer

Electronic Warfare Signals Intelligence Supply Chain Operative Power Engineer"

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. I am writing to advise you that following a search of our recorded information, I have established that some information you requested is held by the Ministry of Defence and is below. Please note that course lengths for Class 1 for the Royal Signals roles is not held as these courses have not yet been finalised.

In response to your request, please see below the course lengths for Class 3.

Please note that Supply Chain Operative trade training is followed by 8 weeks training at the Defence School of Transport in Leconfield. The first three courses (Information Services Engineer, Networks Engineer and Infrastructure Engineer) are completed in three phases. First foundation stage lasts 4 weeks, this is followed by the second foundation stage which lasts 10 weeks. Remainder length is spent on training specific to trade. Remaining three courses (Electronic Warfare Signals Intelligence, Supply Chain Operative and Power Engineer) are completed as foundation stage which lasts 4 weeks. Remainder length of the courses is specific to trade. Under Section 16 (Advice and Assistance) you may find it useful to note that old course titles will be replaced by the new trade titles listed in the table in the near future. Training for some of the new courses will commence from April 2020. Remaining courses will follow in April 2021.
