SPLI – Quarterly Update – 1 Oct 19 to 31 Dec 19

Introduction

1. This is the latest quarterly report of Service Police Legacy Investigations (SPLI). It covers the period from 1 Oct 19 to 31 Dec 19. In this quarter, SPLI has closed, or is in the process of closing, 2 full investigations and 3 directed lines of enquiry.

Caseload

- 2.1 Since SPLI took on the remaining legacy cases, on 1 Jul 17, it has closed, or is in the process of closing, 1198 allegations.
- 2.2. As at 31 Dec 19, SPLI's caseload consists of 10 full investigations and 8 directed lines of enquiry, which account for 82 allegations.
- 2.3. An individual investigation, or a directed line, can be made up of multiple allegations. It is important to note that one allegation does not always equate to a single investigation or directed line.
- 2.3. One allegation remains in case assessment.

Referrals

- 3. SPLI inherited one referral from IHAT to the Service Prosecuting Authority (SPA). It has since been discontinued by the SPA.
- 3.1. In April, the Service Police referred three individuals to the Service Prosecuting Authority (SPA) in relation to two separate incidents, in which two Iraqi citizens died in the custody of UK armed forces in 2003. In July 19, the SPA decided that no charges should be directed in this case.
- 3.2 At the end of September 19, the Service Police referred two individuals to a nominated Commanding Officer in relation to offences linked to alleged assaults and abuse of Iraqis held by UK armed forces in April 2004. In October 19, the CO referred the individuals to the SPA. The SPA decided no charges should be directed in this case.
