Thank you for your recent email, which was processed under the Freedom of Information Act 2000 (FOIA). For clarification, you requested the following information:

I am writing from the Listed Property Owners' Club Campaign For Owners. We are contacting you regarding the Planning (Local Listed Building Consent Orders) (Procedure) Regulations 2014, which made provision for allowing local planning authorities to issue general consent for specific types of work to listed buildings within their authority. These regulations make reference to planning authorities notifying "the Commission" of their use of an LLBCO (part 5 of the regulations), which the Ministry of Housing, Communities and Local Government informs us refers to Homes England. As a result we believe that monitoring data regarding the use of LLBCOs must be held by Homes England as a statutory provision of the regulations.

As a result we are requesting the following data under the Freedom of Information Act:

 Any and all data held by Homes England regarding the number of local listed building consent orders that have been made since the 2014 regulations came into effect, including which planning authorities have used LLBCOs.
Any data held by Homes England regarding cost or resource savings that have been realised as a result of LLBCOs being used.

3. Any studies undertaken regarding the effectiveness of LLBCOs as an instrument.

If this data is not held by Homes England we request to know which public body does receive notifications regarding LLBCO's from local authorities, pursuant to the 2014 regulations. If Homes England is not "the Commission" as referenced in the regulations, then which body does this make reference to? As a matter of law, some central body must be in receipt of the data involved and must be holding it in accordance with transparency regulations; we would find it distressing to discover that no-one within central government knows which body this is or if this is being carried out.

Response

I am able to confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.

In order to conclude that the information is not held, we have searched with our Valuations and Disposal team who would have the information requested if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.
