Thank you for your request, which was processed under the Freedom of Information Act 2000 (FOIA). For clarification, you requested the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following statistics from yourselves:

How many properties in England meet the following conditions:

- 1) Are owned by individuals for buy to let purposes
- a)How many of these properties currently have active tenants in them?
- 2) Are owned by individuals who do not reside in the property in question and are not owned for the purpose of renting/letting
- a) How many of these individuals hold British Citizenship?
- b) How many of these properties have no occupants residing in them?
- 3) On average, how many properties does a person who has invested in property for purposes other than living in them in England own?
- a) What is the most and least common type of property owned by these individuals?
- b) What is the average cost of these properties?
- 4) How many properties in England are "Leasehold"?
- 5) How many properties in England are "Freehold"?

Response

I am able to confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.

Homes England is a government agency which provides funding support to Help to Buy and Shared Ownership properties.

In order to conclude that the information is not held, we have searched with the relevant teams who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.

4) How many properties in England are "Leasehold"?

The total leasehold homes (not including flats or studios) from April 2013 - end Sep 2018 was 17,977 or 9% of total Help to Buy completions.

5) How many properties in England are "Freehold"?

The total freehold properties from the same period as above equates to a total of 146,998.
