It is my understanding Homes England (previously the Homes and Communities Agency) lease the property from Derby City Council.

The HCA leased the property to a sole trader business between November 2012 and October 2017. I understand when the lease expired, the HCA took the decision to not pursue outstanding rent arrears at the property. I would be grateful if you could confirm the following;

- the amount of arrears
- the date the decision was taken to not pursue the arrears
- which individual and/or department took the decision to not pursue the arrears
- how and where the decision was reflected in the HCA's accounting statements

Response

We are able to confirm that we do hold the requested information. We will address each of your points in turn.

- 1. The amount of arrears was £15,203.98.
- 2. The date the decision was taken to not pursue the arrears was 01/11/2017.
- 3. Which individual and/or department took the decision to not pursue the arrears

 The agency had pursued the debt and taken advice that the debt was not recoverable. This view was accompanied by supporting documentation which then formed a write-off proposal. This proposal was approved by the General Manager of Finance and Performance.
- 4. How and where the decision was reflected in the HCA's accounting statements

The provision for the bad debt was made in our accounts on 31/03/2018. It was written off in October 2018 when the final decision not to pursue the arrears was made. We comply with HMT's (Her Majesty's Treasury) disclosure requirements for Losses and Special Payments.
