Thank you for your request for information, which was processed under the Freedom of Information Act 2000 (FOIA).

For clarification, you requested the following information:

I am trying to ascertain whether or not the contracts below have been awarded yet and if so, are you able to tell me who to?

1. *Walkmill Lane, Cannock, 116 dwellings. Includes access road. Former Parker Hannafin site, Submission date 05/10/2018*
2. *Land of Rudgate Park, Thorp Arch, Wetherby, Phase 2 - 119nr New Houses, Submission date 08/02/2019*
3. *Former Colt International, New Lane, Havant, Construction of up to 100 new homes, Submission date 01/03/2019*
4. *Land of Rushenden Road, Queenborough, Enabling & Remediation Works to a former mill site, Submission date 05/04/2019*

Response

We can confirm that we do hold some recorded information that falls within the scope of your request we will therefore address each of points in turn below.

- 1) Walkmill Lane, Cannock – The contract has been awarded to Galliford Try Partnerships LTD.
- 2) Land at Rudgate Park – We can confirm that we do not hold recorded information that falls within the scope of your request. To clarify, the Agency has not yet awarded the contract and so therefore we do not hold the recorded information to provide a response to this part of your request.

Discretionary Disclosure

We can however inform you (outside of the FOIA) that the Agency has concluded the evaluation of the procurement process and will be making a recommendation to an internal governance meeting in July. To confirm, we have not formally awarded the contract but we have told the bidders informally whether they are / are not being recommended as preferred bidder.

- 3) Former Colt International – The contract has been awarded to Galliford Try Partnerships LTD (subject to the contract being signed by both parties).
