Response

We can confirm that we do hold information relating to your request. We will address each of your points in turn.

 How much financial support/funding/grants has Countryside Properties plc received from the government/Homes England or other respective governmental entities over the last 3 years? We only hold information relating to financial support/funding/grants received from Homes England and not from other government departments.

We can confirm that Countryside Properties PLC have not received any financial support/funding/grants from Homes England within the past three years.

In order to conclude this, we have searched with our Investments and Programmes teams who would have the requested information.

2) Can you please list all projects that the government/Homes England has entered into an agreement with or collaborated with Countryside Properties plc over the last 3 years. We only hold information relating to projects/agreements entered into by Homes England and not from other government departments.

a) Help to Buy Programme

Countryside Properties PLC are actively participating in the Help to Buy Programme. There is established regular engagement between Countryside Properties PLC and the Homes England Help to Buy team in

the context that they are one of our developers, with an approved forecast that are delivering Help to Buy across their sites.

Our Help to Buy Relationship Management team last met with Countryside Properties PLC on 3rd June 2019 as part of our regular meetings with our key developers.

Help to Buy is financial support in the form of an equity loan, paid at purchaser legal completion to individual purchasers. As such it is not funding or financial support to the developer and as such does not apply to question 1 above.

b) Freeks Farm

Homes England have entered into an Agreement For Lease with Countryside Properties PLC in relation to the Freeks Farm site at Northern Arc, Burgess Hill for the delivery of 460 homes.

Countryside Properties PLC were appointed on a competitive basis through the Delivery Partner Panel 3 (DPP3) framework, and were selected as the preferred bidder or the site in March 2019.

Countryside Properties PLC acquired Westleigh Partnerships Ltd in 2018. Westleigh Partnerships were an Investment Partner with Homes England in their own right participating in the Affordable Homes Programme 2015-2018 and the Shared Ownership and Affordable Homes Programme 2016-2021. Both of these agreements pre-date the acquisition of Westleigh Partnerships Ltd by Countryside Properties PLC.
