I read the news 'Leasehold axed for all new houses in move to place fairness at heart of housing market' published 27 Jun 2019. It mentioned: 'The Communities Secretary has today instructed Homes England to renegotiate contracts...This all comes as a further 18 leading property developers, managing agents and freeholders – including Crest Nicolson and Keepmoat Homes – have signed up to the government's industry pledge, committing them to freeing existing leaseholders trapped in onerous deals where ground rents double every 10 or 15 years. This takes the total number of signatories to over 60'.

As an older pensioner, I just wonder if the names of those developers signed up the pledge with the Homes England would be available for public such that I could approach to a right developer for a size down flat for a peaceful retired life.

Response
