Dear Sir/Madam,

Thank you for your email of 15 October 2019 requesting the following information:

"I would like to receive an updated record of all transactions involving the MOD selling it's residential housing assets to private companies and individuals going back at least to 1990 but preferably as far back as possible.

Ideally this will include the identity of the purchaser and the details of the transaction, namely how many residential units and of what size etc."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information in scope of your request is held.

The information you have requested can be found enclosed at Annex A, but some of the information, namely identity of purchasers, falls entirely within the scope of the absolute exemptions provided for at section 40 (Personal Data) of the FOIA and has been withheld.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the majority of Service Family Accommodation properties sold by the MOD was via the Annington sale. In November 1996 the MOD sold a 999 year lease on 55,060 properties and sold the freehold on a further 2,374 to Annington Property Limited for a price of £1.67 billion.
