We can confirm that we do hold some of the requested information. We will address each of your points in turn.

1) Please provide costs of the recent Homes England delegation to Japan

Homes England's Chief Executive, Nick Walkley, visited Japan on behalf of HM Government (The Department for International Trade and the Foreign and Commonwealth Office) in September as part of a trade mission titled 'Investment in UK Housing and Regeneration'.

The costs for Nick Walkley's trip were as follows:

British Airways return flight (Economy) - £1655.72

Hotel in Tokyo - £673.29

Taxis in Tokyo - £25.76

Trains - London Paddington/London Heathrow - £47.00

2) Please provide the business case for it.

We are able to inform you that we do not hold any recorded information as defined by the FOIA in relation to this part of your request. However, outside of the Act, we can provide you with the following statement:

The event 'Investment in UK Housing and Regeneration' was held to encourage and foster positive trade relationships between both Japanese investors and British business executives with regards to international investment in UK housing. As the Chief Executive for the Government's housing accelerator, Nick Walkley was invited to deliver the keynote address.

We have recently forged a new partnership with Sekisui House, Japan's biggest housebuilder, alongside Urban Splash, a UK Small to Medium Enterprise (SME). The multi-million pound deal will see the two companies work with Homes England to deliver thousands of new homes across England. The Sekisui House partnership has been made possible with funds from the Home Building Fund (which is managed by Homes England) and will bring skills in modular, sustainable and fast-paced construction to boost housebuilding in the UK.
