Thank you for your request for information which we have processed in accordance with the Freedom of Information Act 2000.

For clarification, you requested the following information which refers to your previous request for information RFI2578:

1. Regarding [HE-Document 1.4] = Disclosure of documents relevant to or related to the Allocation Mechanism which was agreed by HCA and CLG on 08 September 2011 ??? as indicated in Annex A.
2. Regarding [HE-Document 1.4] and [HE-Document 1.5], = Disclosure of documents relevant to or related to the Allocation Formula being used in your calculation. If the breakdown of £9.3m for each of the 5 schemes in Liverpool was not available, PLEASE use one of these schemes which had successfully received an allocation from the £9.3m given by Homes England, as an illustration and also that for or related to the Welsh Streets Area.
3. Regarding [HE-Document 1.5] = Disclosure of documents relevant to or related to documents in the missing Web Link [HMR Transition funding has now been announced <http://www.communities.gov.uk/new/cororate20>] which was stated in the email of 24 November 2011 in Annex A.
