You own (or used to own) the freehold interest of title number DN520111 in Plymouth, prior to it being sold to a developer. You contracted an estate management company to collect an estate rent charge, community service charge and management fees for the management of the whole estate under title number DN520111. The managing agent that was nominated by Homes England is Devonport Property Management Company Limited (06510295)

Please could you provide a full breakdown of all the estate service charge fees paid to this company, and the expenditure for the past 5 years, as well as management and maintenance fees, total service charge collected by the management company on your behalf and sinking fund if there is one. Please also provide a breakdown of the service charges paid per zone (I understand the area is split in multiple zones being Zone A, B,C each paying different estate service charges)

Response

I can confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.
