Thank you for your request for information, which was processed under the Freedom of Information Act 2000 (FOIA).

For clarification, you requested the following information:

I'm writing an article about the Millennium Dome, which is coming up for 20 years old. I have some questions relating to its legacy, which was partly the responsibility of your predecessor English Partnerships:

- the official cost given for the Millennium Experience was £789m. Did that include the cost of decontamination of the Dome's site
- do you have more detail on how the £789m breaks down, or should I go to another department, such as the DCMS, for this?
- did this figure include the cost of decontamination of the surrounding land, that was eventually sold to Meridian Delta?
- as I understand it, the deal with Meridian Delta included the 24 acres covered by the Dome itself, 24 acres of land immediately around it, and an additional area of 86 acres: are these figures correct?
- what was the sum for which the above land was sold to Meridian Delta?
- what was the percentage share of future profits that would be returned to the public sector under this agreement?
- at the time it was said that "up to" £550 million would be returned to the government. Has this figure been reached? Can you say how much has in fact been returned to government? And how much do you expect in the future?

Response

I can confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.

In order to conclude that the information is not held, we have searched with our Legal Land Team who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.
