FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: BODY WORN CAMERAS.

We refer to your email dated 29 October 2019 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- "1. How much money did your police force spend on body-worn cameras (BWC) in 2017/2018 or 2018, depending on how the annual period is being counted.
- 2. How much money did your police force spend on body-worn cameras (BWC) in 2013/2014 or 2014, depending on how the annual period is being counted.
- 3. How much money did your police force spend on body-worn cameras (BWC) between the annual period of 2013/2014 (or 2014) and 2017/2018 (or 2018) depending on how the annual period is being accounted for.
- 4. How many formal complaints directly concerning body-worn cameras did your police force receive from the public (recorded for the last available annual period)?
- 5. If so, how many people were detained on the basis of body-worn cameras for the last available annual period (best for 2017 or 2017/2018, depending on how it is counted)."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.
