# The Armed Forces Covenant

An Enduring Covenant Between

The People of the United Kingdom Her Majesty's Government

and -

All those who serve or have served in the Armed Forces of the Crown

#### And their Families

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty.

Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

## **Section 1: Principles Of The Armed Forces Covenant**

- 1.1 We, **COMERA GROUP**, will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:
  - no member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen
  - in some circumstances special treatment may be appropriate especially for the injured or bereaved.

## **Section 2: Demonstrating our Commitment**

- 2.1 COMERA GROUP recognises the value serving personnel, reservists, veterans and military families bring to our business. We will seek to uphold the principles of the Armed Forces Covenant, by:
  - promoting the fact that we are an armed forces-friendly organisation by:
    - o promoting our work, activities and events through our own digital & social media channels
    - o publishing our Covenant pledge on a dedicated Covenant section/page on our web site
  - seeking to support the employment of veterans young and old:
    - welcoming applications from, and guaranteeing interviews with, veterans who meet the criteria in the job specification
    - o recognising military skills and qualifications in our recruitment and selection process
  - striving to support the employment of Service spouses and partners:
    - o welcoming applications from spouses/partners who meet the criteria in the job specification
    - endeavouring to offer a degree of flexibility in granting leave for Service spouses and partners before,
       during and after a partner's deployment
  - seeking to support our employees who choose to be members of the Reserve forces,
     including by accommodating their training and deployment where possible:
    - o staff who express an interest in becoming a reservist are positively supported
    - o up to 2 weeks of leave per year may be available to attend annual training camps
    - accommodation of Reserve training commitments wherever possible
    - fully supporting and accommodating mobilised deployment of Reservist employees if required

- offering support to our local cadet units, either in our local community or in local schools, where possible:
  - o up to 2 weeks of leave per year may be available to attend annual training camps and courses
  - o accommodation of Cadet training commitments where possible
  - o considering sponsorship bids to support worthwhile Cadet projects
- aiming to actively participate in Armed Forces Day:
  - o in advance: promoting through the web, social media, membership and other networks
  - o during: encouraging employees to take part in Reserve Forces Day and any flag raising ceremonies
  - o post: publishing stories on the web, social media, through our own membership and other networks
- offering a discount to members of the Armed Forces Community:
  - registering with the Blue Light Card / Defence Discount Service to offer discounts on our professional,
     movement science and nutritional services for individuals
  - o offering bespoke continuing and/or limited time offers
- Additional commitments:
  - o encourage and support employee fundraising for Service charities
