### **Non-technical summary**

This noise and vibration monitoring report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the Chiltern District (CD) during the month of December 2019.

This report presents data from a noise monitoring installation near to the Great Missenden Haul Road, Link Road and Frith Hill Works worksite (ref. WS01). Inspection works and road upgrades to the compound at Frith Hill were carried out in December 2019. During the Christmas period the worksite was shut down and no works were undertaken.

Two exceedances of the SOAEL were measured during night time works undertaken at the Link Road roundabout. Noise levels were in line with S61 predictions and no further exceedance of S61 trigger levels were measured due to HS2 related works during the monitoring period. One complaint was reported to HS2 for the CD region during the December monitoring period.

#### 1 Introduction

- 1.1.1 The nominated undertaker is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
  - monitoring the impact of construction works;
  - to investigate complaints, incidents and exceedance of trigger levels; or
  - monitoring the effectiveness of noise and vibration control measures.

Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the Chiltern District (CD) for the period 1<sup>st</sup> to 31<sup>st</sup> December 2019.

- 1.1.2 Active construction sites in the local authority area during this period include:
  - Great Missenden Haul Road, Link Road and Frith Hill Works, worksite reference WS01 (see plan 1 in Appendix A)
    - Works activities include inspection works and road upgrade works close to the compound at Firth Hill, at the site entrance and at the Link Road roundabout.
    - Utility upgrade works at Northmoor Water Treatment
- 1.1.3 The applicable standards, guidance, and monitoring methodology is outlined in the construction noise and vibration monitoring methodology report which can be found at the following location <a href="https://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2">https://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2</a>. #### 1.2 Measurement locations

- 1.2.1 One noise monitoring installation was active in December in the CD area. The noise monitor was installed in January 2019 at a position near the site entrance off the roundabout on the link road A413 and relocated in April to a temporary position within the site compound. The monitor was subsequently relocated to its permanent position on 6<sup>th</sup> of November, once the hoarding works were complete.
- 1.2.2 Table 2 details the address of the noise monitoring installation within the CD area in December 2019. A map showing the positions of noise monitoring is also presented in Appendix B.

## 2 Summary of results

#### 2.1 Exceedances of LOAEL and SOAEL

- 2.1.1 The lowest observed adverse effect level (LOAEL) is defined in the Planning Practice Guidance Noise as the level above which "noise starts to cause small changes in behaviour and/or attitude, e.g. turning up volume of television; speaking more loudly; where there is no alternative ventilation, having to close windows for some of the time because of the noise. Potential for some reported sleep disturbance. Affects the acoustic character of the area such that there is a perceived change in the quality of life".
- 2.1.2 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."
- 2.1.3 Where construction noise levels exceed the SOAEL, relevant periods will be identified and summary statistics provided in order to evaluate ongoing qualification for noise insulation and temporary rehousing.

2.1.4 Table 3 presents a summary of recorded exceedances of the LOAEL and SOAEL due to HS2 related construction noise at each measurement location over the reporting period, including the number of exceedances during each time period.

2.1.5 For the purpose of assessing eligibility for noise insulation or temporary rehousing, multiple exceedances of the SOAEL in a 24-hour period would be counted as a single exceedance during that day. Over the reporting period, the overall number of SOAEL exceedances at each measurement location is shown in Table 4 and may be lower than the total sum of individual exceedances reported in Table 3 for each location.

2.1.6 HS2 main construction activities were undertaken between 08:00 and 18:00 on weekdays and between 08:00 and 13:00 on Saturdays. SOAEL exceedances were measured during night works on at the Link Road roundabout the 10<sup>th</sup> and 11<sup>th</sup> of December. Noise levels above the LOAEL were measured during periods of works and outside working hours, likely due to road traffic noise from the A413.

#### 2.2 Summary of measured noise levels

2.2.1 Table 5 presents a summary of the measured noise levels at the monitoring location over the reporting period. The  $L_{Aeq,T}$  is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period  $L_{Aeq,T}$  that was found to occur within the month.

- 2.2.2 Appendix C presents graphs of the noise and vibration monitoring data over the month for each of the measurement locations. Noise data presented includes the hourly L<sub>Aeq</sub> values and, where relevant, the L<sub>Aeq,T</sub> values (where the time period T has been taken to be the averaging period as specified in Table 1 of HS2 Information Paper E23). - 2.2.3 Given the limited nature of works undertaken in the CD region, the measured noise levels are largely attributable to underlying, ambient noise (road traffic) rather than being attributable to construction activities.




#### Noise monitoring plan - 1






