The Quick Check is a proposal checking service, offered to customers requiring advice quicker than Natural England's statutory time frame, in order to commence works. It is not suitable for complex cases, which require specialist input or site visits. Once this form has been completed, signed and received by Natural England, the check can be completed within 2 working days. Quick Check carries a one off fee of **£200.00 + VAT** (the "Fee"). Quick Check doesn't guarantee a timescale for the determination of the Notice itself, but if the draft proposal is verified as complete, determination of the subsequent submitted notice is likely to be quick.
