## FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: MEDICAL STANDARDS.

We refer to your email dated 5 November 2019 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

"Hello, I would like to request some information in relation to the medical standards that are in place.

Firstly I would like to know why a candidate must have good colour vision and how suffering from Colour Deficiency will have a detrimental effect on a persons ability to perform the role of a Authorised Firearms Officer.

Secondly, I would like to know why the Ministry Of Defence Police are asking for the 3rd Edition City University Colour test to be carried out when all other Home Office forces ask for the 2nd Edition and most importantly as to why you have elected to use a test that is not validated."

A search for information has now been completed by the Ministry of Defence Police (MDP) and I can confirm that we do hold information in scope of your request.

The MDP mirror the College of Policing medical standards for Authorised Firearms Officers (AFO). The recommended overarching national policy on colour vision was circulated by the National Police Chief's Council (NPCC) on 12 March 2018. This states that the two principle

points that support the AFO colour vision standards are based on "the ability to identify a subject based on a description, of which colour could be a significant factor, particularly where this may lead to pre-emptive use of force or cricital shot. The ability to operate firearms with a "red dot" sight system. Both points are critical to the lawful and proportionate use of force.

The NPCC circular stated that some forces had identified that the 2nd edition City test is no longer commercially available. The standards were updated with details for the 3rd Edition test and Forces that already have access to the 2nd edition test could continue to use it. The MDP do not have direct access to colour vision testing. Where potential new recruits and incumbent officers are unable to access the City test (or the Farnsworth test) in the high street it is recommended that they contact the nearest university with a vision department. The universities used to date all have the 3rd edition test available.
