Thank you for your e-mail of 18 December 2019 asking for details about a range of aircraft. Specifically, you requested the following information:

"I am interested in the tail numbers and squadron assignments as of 1 October 2019 of the following Ministry of Defence aircraft:

Grob Prefect, Grob Tutor, Texan T. Mk1, Hawk T1, Hawk T2, P-8, Bell Griffin HT1, Bell Griffin HR1, Bell Griffin HR2, Phenom 100, Hawker Beechcraft Corp B300 Avenger T.1, Britten-Norman Defender AL.2, Wildcat AH.1"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). We have now completed a search of our paper and electronic records for the information you requested and I can confirm that some information within the scope of your request is held.

Details of aircraft tail numbers and the squadrons the aircraft are allocated to are given in the attached annex. The information excludes contractor owned or operated aircraft. You may also wish to note that Poseidon did not enter RAF service until the end of October 2019 so is excluded from the list. The Hawk T2 is allocated to No. 4 Flying Training School and the aircraft pooled for use by IV and XXV(F) Squadrons. The Wildcat AH1 is split between 661 and 659 Squadrons Army Air Corps (AAC) and 847 Naval Air Squadron (NAS).
