JUDGMENT BY CONSENT

UPON the Claimants (as set out in attached Schedule 1) ("**Schedule 1 Claimants**"), the First Respondent and the Second Respondent agreeing terms by consent;

BY CONSENT it is ORDERED THAT:

- 1. A protective award pursuant to section 189 of the Trade Union and Labour Relations (Consolidation) Act 1992 is made in respect of the Schedule 1 Claimants and the First Respondent ordered to pay remuneration to the Schedule 1 Claimants for a protected period of 50 days from 11 October 2018 (being the date on which the first of the dismissals to which the complaint relates took effect).
- 2. Subject to the normal categories of preferential debts set out in Schedule 6 of the Insolvency Act 1986, any payments made by the First Respondent (rather than the Secretary of State) pursuant to this judgment will be paid as an unsecured dividend.
- 3. The parties have leave to enforce the terms of this Order without further Order.
- 4. There shall be no order as to costs or interest.
