Thank you for your correspondence of 11 February 2020 requesting the following information:

"Female Engineers commencing Initial Officer Training for the 7 years to RY2018-19 Number of applicants Applicants Boarded Success rate of applicants Boarded (%) Number of Candidates enlisted into P1 training Overall success rate of applicants starting IOT (%) Success rate of boarded applicants starting IOT(%)

The author of one of my documents offers the source of this information as RAF Cranwell Recruitment Services. Could you please advise does this department provide such information as I had always assumed such information would come through DS (AIR) Statistics?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held.

Your Freedom of Information request has been interpreted according to your heading of "female engineers commencing Initial Officer Training for the 7 years to RY2018-19".

In accordance with the Data Protection Act and our obligations in relation to the protection of confidentiality when handling personal data, the data has been rounded to the nearest 10 and a

The recruitment years span from 1 April to 31 March.

Boarded refers to the count of candidates who have been booked on to a board and attended for the given recruitment year.

Intakes are the number of candidates with a phase one date allocated for the given recruitment year.

Under Section 16 (Advice and Assistance) you may find it useful to know that we are unable to offer percentage data, as this is not recorded information.

You may also find it useful to know that the following caveats apply to the above data:

- That Phase 1 training is equivalent to IOT for officer ranks.
- The 2017/2018 figure may not capture all applications due to the introduction of a new reporting system and the requirement to process applications manually during a proportion of the reporting year.
- Recruitment data has been recorded at each recruitment stage and therefore may not necessarily correspond to the same recruiting year.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact us in the first instance at the address above. Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provision of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal process has been completed.
