Thank you for your e-mail of 18 February 2020 asking for Tornado GR4 documentation. Specifically, you requested:

*".....a copy of a blank mission data card of a Tornado GR4 squadron."*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence and I can confirm that information within the scope of your request is held. I attach a blank document known as a Line Up Card which would be prepared by Tornado aircrew during the pre-flight planning process and carried by them during flight.

Under Section 16 (Advice and Assistance) of the Act, you may wish to note that there is not a standard format for these documents and units would adapt them according to local needs.

If you have any queries regarding the content of this letter, please contact this office in the first instance.


