PMI Collective Agreement	(1) The members of IHPN set out in the annex to this notification <b>(IHPN Members)</b> (2) NHS England	Agreement between IHPN Members themselves and with the agreement of NHS England to collectively agree and implement a process for the use of surplus capacity within the independent healthcare sector Provider facilities to specifically be used for Private Medical Insurer ( <b>PMI</b> ) funded and privately funded urgent elective care.	22 April 2020	<p>Agreement for IHPN Members to work collectively with NHS England as commissioner to agree and implement a process by which surplus capacity within independent healthcare sector Provider facilities is used for the provision of urgent elective care services and PMI funded patients. Services to include a triage system of (i) progressing the treatment of 'serious' insurance referrals, (ii) treating 'urgent' care under the current collaboration between IHPN Members and NHS England and (iii) continuing to hold the treatment of any 'normal' care required.</p> <p>The intention is to ensure efficient use of facilities to enable urgent cases to be dealt with where there is relevant local capacity.</p> <p>The process will be communicated to referring PMIs, independent individual hospitals and individual PMIs and it may be that PMI patients are treated at a different facility to that of its insurer, due to available capacity. It is proposed that weekly communications will take place in which individual independent healthcare sector Providers will confirm their capacity to the PMIs for that week. To avoid the information being sent to all PMIs at once, it will be sent by the individual hospital to each individual PMI and not to all PMIs as one single communication.</p>
