It has been two and a half years since we started the implementation phase of the Survey and Inspection Transformation Programme (SITP) and in March 2020 the programme will formally close and the SITP transformation team will disband. Although the programme will close, we, the Assistant Directors for Survey & Inspection, along with colleagues across the MCA, will continue to

support Katy Ware to deliver the quality services that you, our customers expect.

In the meantime, we are continuing with Marine Office refurbishment works, modernising our office and exam room spaces. Liverpool works are currently underway with Belfast and Cardiff works taking place early in the new calendar year.

Also, in development is an eCertification platform that

will allow for the issue electronic certificates in line with IMO regulations; ultimately linked to this will be a customer portal, also covering other services such as ship registration, that will allow companies to access their certificates online and for oral exam candidates to book exam slots online.

Since the start of the SITP implementation phase we have attracted over 35 new recruits of the highest

quality to the MCA, who will, once fully trained give us the resources we need to continue achieving our statutory obligations and meet the needs of our customers. Recruiting a high-quality cadre of surveyors will continue to be a focus beyond SITP to help future proof our reputation as one of the best Maritime Administrations in the world.
