Thank you for your email received by the Ministry Of Defence on 08.11.2019 requesting the following information:

- "1. How many BAME officers are represented by the 2.5% figure published in Oct 2018
- 2. How do BAME officers split by RN/RM, Army and RAF
- 3. How do BAME officers split by each of the ranks e.g. how many at Captain, Colonel, Brigadier level etc
- 4. Is the % of BAME officers trending up or down over time.
- 5. Do you have a breakdown of the BAME offices across the UK armed forces
- 6. Do you have any further breakdown of what constitutes BAME e.g. what proportion/% of Black, Asian and Minority ethnic officers are currently servicing."
