NOTICE TO TRADERS 29/15

IMPORT TARIFF QUOTA FOR EGG AND EGG PRODUCTS FROM UKRAINE

Introduction

This notice is to tell you about an Import Tariff Quota for the import of eggs and egg products from Ukraine.

The quota will be open from 1 January until 31 December 2016 and be divided into four sub-periods as follows:

- 25% from 1 January to 31 March;
- 25% from 1 April to 30 June;
- 25% from 1 July to 30 September;
- 25% from 1 October to 31 December.

The products and quantities available are detailed in Annex 1 attached.

Licence applications

For the subperiod 1 January 2016 to 31 March 2016 you may apply for licences between 1 December and 7 December 2015.

Your application must be for a minimum of 1 tonne and a maximum of 10% of the quantity available for the order number concerned.

In box 8, the country of origin, you must indicate 'Ukraine' and put a cross in the 'Yes box. This means your licence will only be valid to import from Ukraine.

In box 20, special particulars, you must state 'Implementing Regulation (EU) No 2077/2015.'

Your application must be supported by a security of €20 per 100kgs.

Licence security

Your application must be supported by a security of €20 per 100kgs.

In box 11 you should state:

- the amount of security expressed in the same unit of currency that your guarantee is lodged;
- the type of security, for example 'block guarantee', 'cash' or 'single transaction quarantee'; and
- the trader number of the block guarantee holder if you are using another trader's block guarantee.

If you are using another trader's block guarantee you must make sure that your cross reference details are set up before you send us your application.

Note: We will reject your application if the cross reference is not set up and you do not submit security in another format within the application period.

We will not accept any amendments to block guarantees after the application period has closed. This includes cross reference amendments.

Licence issue and validity period

Your licence will be issued as from the 23rd day of the month in which the application was submitted.

Your licence will be valid for 150 days. However, licences will not be valid beyond 31 December 2016.

Release of security

You must return your paper licences within 45 days of the expiry date or you will forfeit your security.

Security against the main electronic licence (excluding extracts) will be released automatically upon attribution of at least 95% of the licence quantity.
